PRESIDENT'S MESSAGE

Greetings,

Your LWVCBC has been busy this January, and there is a lot for us and you to do this year. A big concern is state legislation being proposed to further restrict voting rights and to make it more difficult, likely impossible, for the public to get initiative petitions on the ballot or get them passed.

Several members of our LWVCBC Board attend the Missouri Voter Protection Coalition (MOVPC) Zoom meetings every Monday at 10 a.m., headed by Denise Lieberman. The meetings are attended by over 100 participants representing organizations throughout the state concerned about preserving voting rights.

Regular attendees from our league are Marilyn McLeod, Carol Schreiber, Ruth Milledge, Sharon Schneeberger, and myself. By attending these weekly meetings, we stay current on what is going on in Jefferson City and how we can all collaborate to educate and advocate for voting rights in Missouri.

Already a number of bills have been filed - and are being heard in committees - that seek to limit voting or to make it more difficult to get initiative petitions on the ballot and virtually impossible for voters to pass.

HJR43 would increase the number of signatures needed to place a measure on the ballot and increase the threshold for passage from a simple majority to 2/3 - a nearly impossible threshold.

HJR 30 would require proposed constitutional amendments to receive not just a majority of votes cast statewide (the rule now) but also to prevail in a majority of state legislative districts.

HJR 18 would increase the number of signatures required to place proposed constitutional amendments on the ballot, only allow them to be on the ballot during a general election, and increase the threshold for passage from a simple majority to a 2/3 majority.

HJR 24 & 25 increase the threshold for passage of a constitutional amendment to a majority of <u>all registered voters</u> in the state. Currently, measures pass when they receive a majority of votes cast.

SB44 Requires local election authorities to investigate the qualifications of any person who has not engaged in voter activity for two years. The election authority would be required to include those voters in any canvass that would lead to being purged from the rolls.

This directive could lead to Voter Purges beyond the National Voter Registration Act of 1993 (NVRA) and target low propensity voters, voters of color, those with disabilities, seniors, and others with health conditions. Voters presently cannot be removed from the rolls solely for failure to vote. As Denise Lieberman of MOVPC says, this bill "opens the door to investigations of populations who already face the greatest barriers to voting." We should be taking steps to make it easier and more convenient for low propensity voters to vote, not subjecting them to investigation.

Our local League will be monitoring Legislation in Jefferson City during this session and sending out emails to members when live and/ or written testimony is needed.

You may also want to join Missouri Voter Protection Coalition (it is free). They have excellent information and updates and have been very active in legally challenging several recent laws that make it more difficult to vote. You can also attend the weekly Monday Zoom meetings, if you are so inclined. Go to their website: https://www.movpc.org and scroll down to the bottom of the page to join.

COLLEGE HONORS FOUNDING MOTHER

With several members of the League of Women Voters of Columbia-Boone County attending, Brad Lookingbill, Columbia College's distinguished history professor on Thursday paid tribute to a college founder - Luella St. Clair Moss.

The event in a former gym in Dorsey Hall was for Columbia College Charter Day. It was 172 years ago Thursday when the State Legislature granted the charter for what was then Christian Female College, later becoming the coeducational and worldwide Columbia College.

College President David Russell in his remarks acknowledged the League of Women Voters members present and their effort to name the next elementary school in Columbia Public Schools for St. Clair Moss.

"We agree that this would be a fitting tribute to a leader who shattered many a glass ceiling," Russell said.

St. Clair Moss served three non-consecutive terms as college president, the first in 1893 when her husband, who was the president, died suddenly. Between 1893 and 1920, she oversaw enrollment growth from 50 to 150, Lookingbill said.

"The 28-year-old widow was one of the first women to helm an institution of higher learning," Lookingbill said.

St. Clair Moss embraced the junior college concept, he said. She sold U.S. government Liberty Bonds during World War I.

She founded the Columbia Equal Suffrage Association in 1912, campaigning for the right of women to vote. She was president of the Missouri League of Women Voters from 1925 to 1927 She was the first woman on the Columbia Board of Education in 1922. That year, she ran

for Congress, the first woman nominated for Congress from Missouri.

Lookingbill quoted from some of her campaign appearances.

"Political life, to be well balanced, needs men and women," Lookingbill said, quoting St. Clair Moss.

Another quote: "I have outsat many long sessions in committees where I have been the only woman. I have never been smoked out. In fact, I must be what they call a man's woman since I work very happily with men."

Lookingbill provided yet another quote from her 1922 campaign.

"Men will be able to develop more fully and completely when women are developed beyond the state where they are parasites," Lookingbill said, quoting St. Clair Moss

Campaigning in 40 towns in the district, she traveled over 5,000 miles in a car driven by University of Missouri student John Dalton, a future Missouri governor.

"She had a mind for detail and a broad vision for the country," Lookingbill said.

He read from a St. Louis Post-Dispatch piece advocating for her election, stating that for a man with her qualifications election would be certain. It went on to state that if she were defeated, the only reason would be that she's a woman.

"Luella did not gain enough male votes to win," Lookingbill said.

St. Clair Moss died in 1947 and is buried in Columbia Cemetery. Lookingbill said hers "is the face of this institution."

"Today we remember the centennial of her campaign for Congress with pride, enormous pride," Lookingbill said.

"It was great to hear from Lookingbill about the details of St. Clair Moss's life, said Barbara Hoppe, president of the Columbia-Boone County League of Women Voters.

"She's just an outstanding woman," Hoppe said. "We're excited about the opportunity to get the next school named after her."

APRIL ELECTION CANDIDATE & BALLOT ISSUES FORUM MAR. 7

The LWV and the Columbia Public Library will cohost a Candidate and Ballot Issues forum on **Tuesday, March 7, at 6:30 p.m.** in the Friends Room. The forum will feature the candidates and ballot issues on the April 4th ballot. Races will include the Columbia School Board and Columbia City Council Wards 1 and 5. This hybrid forum will have an in-person audience and a Zoom audience.

There are six candidates for the Columbia School Board: Paul Harper, John Potter, Chris Horn, James Gordon, John Lyman, and April Ferrao. The library's hybrid setup cannot accommodate six candidates at one table, so we will interview the candidates one at a time. To avoid putting the first candidate interviewed at a disadvantage, we will provide the questions to all the candidates ahead of the forum. Candidates will have a two-minute opening statement and a one-minute closing statement.

The Columbia City Council candidates for Ward 1 are Pat Fowler and Nick Knoth; candidates for Ward 5 are Donald Waterman and Gregg Bush. With fewer candidates to interview, we can use

our normal forum setup with candidates seated side-by-side. Candidates will answer moderator and audience questions and have a two-minute opening statement and a one-minute closing statement.

The April ballot will also feature Columbia and Boone County ballot issues related to marijuana sales taxes. We will have informational speakers for these issues.

To attend the forum on Zoom, go to <u>dbrl.org</u> to sign up. David Lile will be our moderator and KFRU and KOPN will broadcast the forum live.

We will create a Voters' Guide to help voters learn about items on the April 4th ballot. The Guide will provide school board and city council candidates' responses to a set of relevant questions and information on the Columbia and Boone County marijuana tax ballot issues. We hope to have the Voters' Guide available by March 15. A link will be sent to our members and posted on our LWVCBC website.

WHY DOES THE SUNSHINE LAW MATTER FIFTY YEARS LATER?

Passed in 1973 with bipartisan support and signed into law by then-Governor Kit Bond, Missouri's open records law was intended to shed some "sunshine" on government proceedings in the wake of the Watergate scandal. It was a promise to do the public's job honestly and transparently. For the first time, it guaranteed the public's right to have access to their government's business.

Previously, public bodies (including state and local elected officials and executive branch offices) were free to do their work in the dark. They did not have to let the public know when they were meeting, what they were discussing, or who was influencing their decisions, and they did not have to provide written records to the public or the press. In other words, they could act in secrecy without accountability.

Over the years, the law has been updated several times. It was expanded in 2004 to include the public's right to record a public meeting, but unfortunately, the state Supreme Court decided that the law did not apply to the legislature. The passage of the Clean Missouri ballot issue in 2018, however, made sure that it does apply.

Now, as we celebrate the 50th anniversary of this law that is so important to modern democracy, the Governor and the legislature have targeted the Sunshine Law as needing "improvement." Multiple bills have been filed, some of which would drastically roll back the law so the public would have access only to formal proceedings and records of decisions already made but not to the actions, correspondence, or meetings leading up to those government decisions.

Members of the Missouri Sunshine Coalition, including the Missouri Press Association, are closely monitoring this legislation, and we will share information with LWV members as the legislative session unfolds. Fair and open government is a core value of the League, and we must continue to shine the light of accountability on governments at all levels.






