NOVEMBER BOARD MEETING REPORT

The League board met on November 18 at the Unitarian Universalist Church.

Pam Springsteel, chair of the 100th Anniversary Committee, reported that the Columbia School Board named the new middle school for someone other than our suggestion of **Luella St. Clair Moss**. We will urge the school board to name the new 2022 elementary school for Luella St. Clair Moss.

Kate Canterbury updated the board on plans for the centennial event on December 11, from 6-8 p.m. at **Dog Masters Brewery**. Brianna Lennon will speak at the event and provide pizza. See the related article on pg. 3.

The Stephens College **Suffragette Fashion Show** will continue into next semester.

Remember that our very own exhibit is ongoing at the **Boone County History & Culture Center**. We hope you will plan to visit them.

The **Equali-Tea** with AAUW is confirmed to be at the First Baptist Church on February 15.

Legislator Night has been re-named a more friendly title: "Conversations with Your Legislators." The Board approved an Ed Fund request to cover the costs of rental for ARC meeting rooms and ads for the event. We were pleased to learn that Representatives Cheri Reisch, Martha Stevens and Kip Kendrick plan to attend. Each legislator will speak for five minutes about their priorities, followed by questions from the audience, and then the session will break into small groups for constituents and legislators to converse.

Lunch & Learn - Barbara Hoppe reported on plans for upcoming Lunch & Learn programs

(see article on Dec. L&L on pg. 3). Marilyn reported she has talked to a representative from the City of Columbia about their Inclusivity Impact Institute, and the Board decided that would be a good topic for the May L&L.

Tracking for Making Democracy Work (MDW) and People Powered Fair Maps grants – Marilyn and Carol reminded Board members that we need to track volunteers, hours of volunteering and any expenses paid (and not reimbursed) for our events related to both grants. As part of the MDW grant, we will be provided with access to the state VOTE411 online election information resource. Mahree Skala volunteered to help with the VOTE411 voter guide.

As part of the MDW Grant, local Leagues are asked to set a plan and goals for fundraising. The Board discussed changes to the statement to include not only financial contributions but all of the contributions our Board regularly makes and how that fulfills the requirement.

LWVUS Day of Action - Local Leagues are encouraged to sponsor a Day of Action on February 14, the 100th anniversary date of the national League. Carol Schreiber had forwarded a list of possible actions. The Board decided to send Valentine cards to all our elected officials thanking them for serving (see more on pg. 8).

This month is the 100th Anniversary of our local chapter of the League of Women Voters! This is cause to celebrate! Many local chapters around the state and the country have disappeared over the years, but ours remains strong and very active! I am so fortunate and (continued on pg. 4)

ERA COMMITTEE UPDATE

The ERA committee met to strategize our next moves based on input from our September 13th event. We will focus on two efforts: educating about and advocating for the ratification of the ERA in Missouri.

The next legislative session will begin the week of January 7, 2020. The ERA bill will be registered next year as a concurrent bill, due to having



been registered in the past. The ERA bill will then be sent to the Rules and Ethics Committee again. The Rules and Ethics Committee is chaired by Senator Caleb Rowden.

We will reconvene December 16th to refine our smaller group work to move forward on our efforts.

LAWSUIT ON MOTOR VOTOR ISSUE HAS BEEN SETTLED

The League of Women Voters of Missouri and the Kansas City-area chapter of the A. Philip Randolph Institute, an AFL-CIO constituency, filed a lawsuit in April 2018. The lawsuit alleged the Department of Revenue was violating federal voter laws by not automatically updating voter rolls with address changes, and subsequently not providing required registration information to some voters. The lawsuit also blamed Secretary of State for not ensuring federal voter laws are followed.

The lawsuit was settled on November 19, 2019. Under the settlement, the department pledged to update its website within 60 days to automatically redirect users who change their address information to the Secretary of State's site to do the same for voter registration. The voter registration site will automatically populate with new address information provided to the Revenue Department.

"Each year, one of the major causes of disenfranchisement in the state occurs when Missouri voters appear at the polls and find out that they are not registered at their current address," League of Women Voters of Missouri President Evelyn Maddox said in a statement. "These improvements to DOR's voter registration practices will help reduce the number of qualified voters being shut out of the political process."

The changes are set to take effect as Missouri prepares for the 2020 election.

ORIGIN OF THE LEAGUE OF WOMEN VOTERS OF COLUMBIA-BOONE COUNTY



The organization that eventually became the League of Women Voters in Columbia officially began on November 16, 1912, when a group of 18 local citizens gathered at the Athens Hotel. Three were men, including Dr. Richard Jesse, former president of the University of Missouri. Another well known attendee was Mrs. Luella St. Clair Moss, president of Christian College (now Columbia College). They met to "form a working organization of those interested in Equal Suffrage" and formed the Columbia Equal Suffrage Association.

Between 1913 and 1919, the members worked tirelessly to carry the message of suffrage to Columbia, Centralia, Ashland, Hallsville, Rocheport and Sturgeon as well as other parts of the state. Several local members participated in the famous "Golden Lane" at the Democratic National Convention in St. Louis on June 14, 1916. Helen Guthrie Miller, a local suffrage leader from Columbia, served as president of the Missouri Equal Suffrage Association.

The 72-year national struggle for women's equal voting rights finally ended when the U.S. House passed the 19th Amendment in January 1918 and

the Senate on June 4, 1919. It was then submitted to the states for ratification. Missouri was the 11th state to ratify the Amendment on July 3, 1919. Before final ratification by Tennessee a year later, confident that the 19th Amendment would be ratified, the Columbia Equal Suffrage Association changed its name to the Columbia League of Women Voters on December 11, 1919. This preceded the official formation of the national League of Women Voters on February 14, 1920, by a few months. In 1967, the membership voted to rename the organization the League of Women Voters of Columbia-Boone County.

Ever since our formation, our overriding mission has been to encourage, support and protect every citizen's right to vote and to encourage citizens to be informed voters. We study public policy issues as a non-partisan organization, and develop positions on issues — by consensus of the members — after study on the local, state and national level. We are still very actively involved in "Making Democracy Work!"

There was a full house of 66 attendees at the November 19th program "Suffragettes in Silent Cinema" at the Ragtag Cinema. Although many attendees were League members, there were lots of other attendees as well.

This was a documentary of how film was used by both the people who were opposed to women having the vote — and they made sure to make the women seem very unattractive — and those in support. Most of the old films have been lost over time, but remnants of some were woven into the narrative. The film was written and narrated by Kay Sloan,



historian and film director, who shared her knowledge both in the film and in a Skype session following the showing. Discussion was led by Kerri Yost, Associate Professor of Digital Filmmaking at Stephens College.


