Speakers will include Sharon Schneeberger, Chair of the Missouri Fair Redistricting committee and LWVCBC Board Member.

Redistricting is happening in Missouri now. Did you know this process occurs once every ten years and is different in each state? We will explain the process (as defined in the state constitution and Amendment 3) and provide an update. All citizens are urged to stay informed and to call for transparency, bipartisanship, and public input so this process will yield fair maps.

# PRESIDENT'S MESSAGE

I hope everyone is doing well, staying safe and eagerly awaiting your vaccine booster shot, as well as encouraging unvaccinated friends and family to get vaccinated. It is so sad and a needless tragedy that so many people are in our hospitals in Columbia and throughout Missouri, in ICU's and dying, because they are not vaccinated. While we are encouraged that vaccinations have been slowly increasing, it can't happen soon enough.

On a different note, we are encouraged to see that the State of Missouri is finally making efforts to offer Medicaid Expansion to those eligible. The local LWVCBC, the LWVMO, and other local Leagues throughout the state will help make sure eligible people know how to sign up for this important program.

On yet another different note, I had the great pleasure of visiting Alaska for the first time for several weeks in late July through mid-August, as my step-son is working in Seward as an Exit Glacier Hiking and Ice Climbing Guide this summer. It is truly an amazing place. We saw up close many gorgeous glaciers, both in Seward and in the Kenai Fjords, as well as lots

of wildlife - hump back whales, sea lions, otters, seals, puffins, cormorants, grizzlies, moose, Dall sheep, caribou, ptarmigan, and more.

I have included a photo of Exit Glacier, fed by the Harding Ice Field, showing how much Exit Glacier has receded since 2005. This is happening quickly to all the many glaciers we saw. The melting glaciers highlight the urgency of addressing climate change and the disastrous impact it is having and will continue to have on

nature, the weather, and all of humanity's future.

On that note, I want to thank Dick Parker, Win Colwill, and the many other members of the LWVCBC who have worked diligently for many years on this issue. In addition, I would also like to say a special thank you to Columbia's First Sustainability Director, Barbara Buffalo, who worked tirelessly to improve Columbia's climate footprint during her ten years in that position, which she recently stepped down from to care for family. (As a side note, it took me about three years when I was on City Council to convince the City Council, Mayor, and City Manager that the position was vital for the City.) Like most good things - it took time, work, and persistence, qualities the LWV has long had and continues to have.

Thanks to all of you for supporting the LWVCBC in its continuing mission to "Make Democracy Work."

# **ENROLLMENT IS UNDERWAY FOR EXPANDED MEDICAID!**

It's been a long, hard road, but Medicaid expansion is finally being implemented. The Missouri Department of Social Services is taking applications now. Although they will not begin approving new enrollees until October 1, those who apply before that (if eligible) will receive coverage retroactive to July 1.

2020/05/im-1sslsp.pdf. While DSS is updating its online portal, applicants may get the message "ineligible based on income." They should keep going by clicking NEXT, creating an account, and applying.

The Missouri LWV Healthcare Committee is developing a handout for local Leagues to share during voter registration and other public events. Barbara Hoppe and Donna Checkett are leading this project, and we will email it to the members as soon as it's approved.

# **ELECTRICITY UTILITY PLANS**

A study of the Columbia (your) electric utility plans through 2040 by engineering firm Siemens was presented to the Electric Integrated Resource and Master Plan task force on August 26. It addresses: a) electricity sources for 20 years, and b) the Transmission and Distribution system (T&D). Distribution refers to equipment that delivers electricity to customers, while Transmission is the larger and higher voltage lines delivering electricity to the Distribution system. Regarding T&D, the study concluded that we do not need a new substation or a new transmission line. There will be two or more opportunities for public comment before the City Council decides what "your" utility will do.

The LWV adopted a position on global warming in the early 1990s. The Siemens study presented several scenarios in which 100% renewable energy for electricity sold to customers is reached by 2030, 2040, or 2050. They also looked at additional scenarios with 100% renewables by 2050 using different economic and social/governmental assumptions.


They concluded that the cost of achieving 100% renewable energy by 2030 "Early Renewables" would be 7% higher than the 2050 "Reference Case." The city has two contracts for renewable energy to be completed by 2023 (one or both might not be completed by 2024). (cont'd p.5)


(cont'd from p.4) Siemens predicts a considerable reduction in electric demand due to energy efficiency and new rooftop solar. Siemens predicted that between 2024 and 2040, the metric tons (MT) of CO2 production for the 2050 plan would be 7.6 times that of the 2030 plan. Another way of saying this is that the 2030 plan would produce only 13% of the CO2 that the 2050 plan would. Further, with the 2030 plan, 77% of the CO2 produced would be created during the 2020 to 2023 period.

With the 2030 plan, the additional energy cost will increase customer rates less than 1% above the current 3% limit. (Columbia's Renewable Energy Ordinance limits the increase of customer costs associated with the changes to 3%.)

# MISSOURI REDISTRICTING UPDATE

The Missouri House and Senate commissions met Tuesday, August 10, at the Capitol building in Jefferson City for their first organizational meeting. Marilyn McLeod, Carol Schreiber, Nancy Copenhaver, and Sharon Schneeberger attended.

Both commissions completed their constitutional duties by electing officers (chairman, vice-chairman, and secretary), agreeing on rules of order, and setting the public dates and locations for the public hearings.

The Senate set three dates for public hearings: October 18 – Springfield, October 19 – Kansas City, and October 21 - St. Louis.

The House plans six public hearings: October 18 – Springfield, October 19 – Kansas City, October 21 - St. Louis, November 4 - Jefferson City, November 9 – Cape Girardeau, and November 10 - Kirksville.
