Statesman or Politician – the Culture of Fear and Hate

According to Merriam-Webster, a statesman is one who exercises political leadership wisely and without narrow partisanship. Abraham Lincoln differentiated between statesmen and politicians when he said, "A statesman is he who thinks in the future generations, and a politician is he who thinks in the upcoming elections." Unfortunately, it seems lately that too many of our leaders, whatever their party, have become merely politicians with statesmen or stateswomen rarely seen.

As we watch television news and read the newspapers and news magazines, the attention seems to be on division, hatred of those who are different from us, and fear. Is this a result of the times in which we find ourselves or is it being created, and, if so, why? A Wikipedia article on the culture of fear suggests that "deliberate programs of scaremongering vary, but can hinge on the potential for increased social control that a mistrustful and mutually fearing population might offer to those in power..." How is such a culture of fear created? Perhaps through such techniques as "careful selection and omission of news (some relevant facts are shown and some are not); distortion of statistics or numbers; transformation of single events into social epidemics (Salem witch trials); corruption and distortion of words or terminology according to specific goals; stigmatization of minorities; causal inversion (turning a cause into an effect or vice-versa)\; and, finally, outright fabrication of events or claims and then deliberately whipping up outrage at the false claims and fabrications."

Compromise seems to be a lost art, both locally and nationally, with our politicians focused only on what "<u>my</u> people" want, not on what is best for all of us. I don't have an answer to this problem. However, as Meghan McCain, writer for The Daily Beast and daughter of John McCain, recently wrote, "The lines of social acceptability and just plain courteous behavior are becoming harder to define when it comes to politics, and for the first time in a long time I am truly concerned about where this fear and frustration in politics is taking us."

On September 28, Barbara Buffaloe, Columbia's Sustainability Manager, will conduct a special tour of the City Hall Addition's sustainability design features that may enable the building to receive prestigious LEED Silver certification.

LEED (Leadership in Environmental and Energy Design) is a rating program developed by the U.S. Building Council to encourage the design and construction of "green" buildings that conserve energy and water, reduce waste, improve indoor environment, and reduce greenhouse gases.

This event is an unusual opportunity to learn from a LEED Accredited Professional about this green building rating program and to see firsthand many of the unusual materials and innovative design elements in the City Hall Addition that earn certification points.

Learn About the November Ballot Issues

The unit meetings in September will focus on the initiatives on the November ballot, both local and statewide. LWVMO does have a position on the earnings tax ballot initiative (see press release on page 4). Information as to current LWVMO positions which support this stance as well as related back ground information will be available at both unit meetings.



Neither LWVMO nor our local league have any current positions directly related to two other initiatives on the ballot—the proposed ban on tasers and Proposition B (puppy mill restrictions). Although our local league can, therefore, take no positions for or against these issues, we will have pro and con materials related to these issues at the meeting, which will allow members to become more educated on these issues.

The local League does have a position related to the Columbia recreational facilities (Support of improved recreational facilities, including development of the downtown portion of Flat Branch area). At issue is whether or not our League should publicly support the proposed parks tax.

Public Advocacy for Voter Protection Project

The League of Women Voters Education Fund (LWVEF) Public Advocacy for Voter Protection Project has been created to help to bolster its capacity for continuing and expanding its critical state-based advocacy to prevent the disenfranchisement of eligible citizens, particularly underserved populations.

Background:

In 2002, in the wake of the tumultuous 2000 election, Congress passed the Help America Vote Act ("HAVA") to modernize the nation's election processes and to help ensure that eligible voters are no longer deprived of the franchise due to administrative errors.

Unfortunately, in many states, politicians have seized on this opportunity as a means of disenfranchising targeted voters through changes in election laws. These new measures have the potential of disenfranchising more Americans than any Election Day problems we have seen in the past.

In an effort to fight back, the League of Women Voters is focusing on five specific issues:

- 1. Oppose ID and documentary proof of citizenship
- 2. Improve administration of statewide database systems
- 3. Guard against undue restrictions on voter registration
- 4. Improve polling place management
- 5. Improve poll worker training and strengthening poll workers

Note: Missouri is one of the states who have received a grant for this this project. Jo Sapp (Columbia) and Mary Merritt (Sedalia) head up Missouri's efforts.

LWVMO Press Release on Earnings Tax

The League of Women Voters of Missouri strongly opposes the November 2nd, 2010 ballot issue which would mandate an eventual elimination of the earnings tax in St. Louis and Kansas City unless those cities vote to retain the tax. In addition, it would prohibit any other city from adopting an earnings tax.

The present earnings tax provides one third or more of the general revenue for St. Louis and Kansas City. It pays for essential services such as fire and police protection. Were the tax to be eliminated, the cities would have to find another source of income. The only two that would provide sufficient revenue would be either a large increase in the sales tax or the property tax or a combination of the two.

These taxes would be prohibitively higher for residents and businesses alike. Local sales taxes would rise to over 5% in each city. The great disparity between the present sales tax rate and a likely new one would result in fewer purchases being made by those living both within and outside of the city, hurting retail business drastically and in no way making up for the lost revenue.

If the city chose to increase property taxes instead, the sale of homes would decrease, many residents would move to a more competitive location, construction industries would suffer.

In both cases, the tax burden for residents and business alike would increase because the burden would be spread among fewer people. The resulting negative impact to the communities would have a domino effect.

In the present economic climate, especially one in which cities struggle to survive, eliminating a dependable source of revenue, for no predictable gain, is not logical.

The League of Women Voters of Missouri supports an adequate and balanced tax system to finance necessary governmental services which emphases equity and the fair sharing of the tax burden. The tax base should be broad. Communities should continue to rely on the three major tax sources, income, sales and property. Financial stability is an important goal of fiscal policy. The earnings tax meets these criteria. To sustain a representative government, elected officials must be responsible for making fiscal decisions. They are then accountable to the voters for their actions. Therefore, the League of Women Voters of Missouri urges a No Vote on the November 2010 earnings tax ballot issue.

The Cost of Electing State Supreme Court Judges

BRENNAN CENTER FOR JUSTICE

According to a release from the Brennan Center for Justice on August 3, 2010, , spending on state Supreme Court elections (in states without a nonpartisan court plan) has more than doubled in the past decade, from \$83.3 million in 1990-1999 to \$206.9

million in 2000-2009, in a report by the Justice at Stake Campaign, the Brennan Center, and the National Institute on Money in State Politics. For more than a decade, partisans and special interests of all stripes have grown more organized in their efforts to tilt the scales of justice their way. This surge in spending—much of it funneled through secret channels—has fundamentally transformed state Supreme Court elections. "This crisis of confidence in the judiciary is real and growing," Justice O'Connor warns in the foreword of the report. "Left unaddressed, the perception that justice is for sale will undermine the rule of law that the courts are supposed to uphold."
