FEBRUARY 2 MEMBERSHIP MEETING TO DISCUSS TWO LOCAL STUDIES, 5:30 P.M. ON ZOOM

Our LWVCBC has been working on two local studies: State Preemption of Local Control and Legalization of Marijuana. These will be presented for member discussion on Feb. 2nd at 5:30 on Zoom. A link for the Zoom meeting will be sent to all members in advance.

A separate article about each of the two local studies, authored by the committee chairs, can be found on page 3 of this issue of *The Voter*.

Here is a short summary of the process the LWVUS uses when establishing a new position on a new issue. First, one or more local League members make a request to their Board that a position be established on an issue for which neither LWVUS nor LWVMO have a position. If the local Board is interested, a Local Study committee of members is appointed to study the issue.

Most studies begin with a proposed objective on a subject, but all sides of the subject must be examined and evaluated. The committee members divide the work and meet regularly for several months to share their research and have discussions. Sometimes

a new or unexpected aspect emerges, or an area thought to be a





positive turns out to be negative, or vice versa.

When the study group is ready, they make a recommendation to the Board. If the Board approves, the study is presented to the membership for discussion and questions. Thereafter, the study position is submitted for consensus to the membership. If approved, it is then presented to the membership at the annual April meeting for approval and thus a new local position is obtained and our local League has another issue to work on.

PRESIDENT'S MESSAGE

Although 2022 has only just begun, your LWVCBC is going strong. Our in-person Jan. 6 Vigil for Democracy was canceled because of cold weather here and in the other locations throughout the state, except for St. Louis. So we quickly helped organize and participated in a statewide Zoom Vigil for Democracy. We had several excellent speakers, including State Rep. David Tyson Smith, representing the Mid-Mo region.

On Jan. 24 we held our biennial meeting on LWVUS Program Planning for 2022-2024 via Zoom. Thanks to all of you who attended, provided valuable input, and got a deeper dive into LWVUS Program Planning. We will have more details on this in our March *Voter*.

We will hold a special Zoom program at 5:30 p.m.on Feb. 2 to present our two recently completed local studies on (1) State Preemption of Local Control and (2) Legalization of Marijuana in Missouri. Be sure to join us and ask questions by chat. Thanks to Chairs Mahree Skala and Dan Viets for their work and leadership on these studies, which will be voted on by the Membership later.

Our redistricting committee, chaired by Sharon Schneeberger, has worked diligently on this important issue and is pleased to report that the Missouri House Redistricting bipartisan Committee reached an agreement on the redistricting maps, and they appear to be drawn in a fair and impartial manner. Much thanks to everyone who testified, wrote, called, and lobbied. This is in contrast to the Senate Redistricting Committee, which did not reach a bipartisan agreement. A decision on those maps will be done by a judicial panel.

Looking ahead, we have a lot of hard and important work to do this year, and we will need "all hands on deck." Marilyn Mcleod, LWVMO President and local Board Member, informed us that there are at least 14 bills filed in the Missouri House that will make the initiative petition process more difficult. This would make it harder for Missourians to circumvent partisan

divides in Jefferson City and directly get things done for the people. Among the most onerous is HJR 79, which would dramatically increase the number of verified voter signatures needed for state constitutional amendments to qualify for the ballot. It would rise from eight percent of the voters in six of the state's eight congressional districts to ten percent statewide. It would also increase the votes required for initiative petition passage from a simple majority to 67 percent.

Missouri's initiative petition system has been in place for 115 years. Two-thirds approval would not only be the highest requirement in the country, it would be virtually impossible to reach. A large majority of Missouri voters recently approved a higher minimum wage, Medicaid Expansion, and medical marijuana, but none passed with more than 65 percent of the vote.

Many thanks, as always, to our Board Members, Committee Chairs, and committee members, who are so dedicated and working so thoughtfully and diligently, and to our regular Members also for all your work and support. Only by working together will we be successful in "creating a more perfect Union" and "Making Democracy Work."

MARIJUANA POLICY

A group of nine LWVCBC members met many times to study adult-use legalization of marijuana. We recommended support of the issue to the board, which approved sending the issue to the membership. An initiative campaign is already underway to put this question on the November Missouri ballot. Eighteen states and the District of Columbia have taken similar steps since 2012, when Colorado and Washington legalized regulated and taxed marijuana use and commerce in their states. The result has been a boon in tax revenue. Notably, there has been no increase in use of marijuana by young people in states that have legalized adult use.

The Legal Missouri 2022 Initiative would allow those over 21 to legally possess, use, and grow limited amounts of cannabis. It would also expunge the criminal records of those with marijuana convictions that did not involve violence or distribution to those under 18. Driving while impaired by marijuana would remain illegal. Resulting tax revenue would support drug treatment, veterans' benefits, and the Public Defender system.

At least 144 new "equity" microbusiness licenses would also be mandated, and awarded by a lottery, with preference to those who have been arrested for marijuana or had an immediate family member arrested; those of limited financial means; and those who have suffered military service-related disabilities. LOCAL CONTROL

The distribution of power between the federal, state, and local levels of government has long been a subject of tension and evolving legal action. In recent years, the Missouri state government has enacted several laws restricting powers that previously had been granted to governmental bodies at the local level. This process is known as preemption of local control.

Some of these restrictive new state laws contradict policy positions held by the League of Women Voters of Missouri. The LWVCBC has studied this issue and developed a local policy position on preemption to guide our issue advocacy efforts.

This study will be reviewed and discussed on Zoom February 2 at 5:30 p.m., along with the Marijuana Policy Study. Members will have an opportunity to ask questions about each of the studies. A Zoom link will be sent to all members by email.

The report of our committee will be distributed to all members in advance, and we look forward to this discussion.

The next step after that will be a meeting in early March to develop a consensus on whether to adopt the report for local advocacy purposes and recommend it to the League of Women Voters of Missouri as a state policy position.

CANDIDATE AND BALLOT ISSUES FORUMS IN MARCH

The LWVCBC forum for ballot issues and the Columbia School Board candidates will be Tuesday, March 15, at 6:30 p.m. LWVCBC president Barbara Hoppe will moderate. The candidates for two seats on the school board are Suzette Waters, Blake Willoughby, Andrea Lisenby, and Adam Burks. Ballot issues include Columbia and Boone County internet sales tax proposals and the Columbia Public Schools bond issue. Dr. Brian Yearwood, CPS superintendent, will make a presentation on the school bond issue and answer questions.

The contests for Columbia mayor and two city council races will be featured on Wednesday, March 23 at 6:30 p.m. Mayoral candidates are

Barbara Buffaloe, Tanya Heath, Randy Minchew, Maria Oropallo, and David Seamon. Candidates for Ward 3 are Roy Lovelady and Karl Skala. Candidates for Ward 4 are Nick Foster and Erica Pefferman. David Lile, KFRU host, will moderate the forum.

Both forums are scheduled to be at the Columbia Public Library and will air on KFRU and KOPN. Current plans are to have limited inperson seating, probably requiring preregistration, and the forums will also be available on Zoom. We will update our members as needed.

MEDICAID EXPANSION UPDATE

According to the January 7 *Missouri Independent*, over 51,000 people have enrolled in expanded Medicaid, and another 69,000 applications are being processed. Processing is slow due to staff shortages and inadequate computer systems, putting Missouri far behind Oklahoma and other states that are expanding Medicaid.

The legislature has begun consideration of a Supplemental Appropriations bill, HB 3014, to fund Medicaid through fiscal year 2021, which ends 6/30/22. This same process has been used every year for a long time. But this year, the funding for the Medicaid Expansion population is included, so there is more controversy than usual even though the Governor has not requested any state general revenue funds to cover

the cost. It's important to inform our elected officials that we support continued Medicaid funding.

The Missouri Supreme Court ruled that the current Constitutional language means the expansion population cannot be separated from the rest of the Medicaid population for appropriations purposes. A bill (HJR 117) has been filed to modify the constitution to impose work requirements and sever the expansion

population from the rest of the program in the budget, which would likely end Medicaid expansion. This would require another vote of the people before the changes could be implemented.

CITY WARD REAPPORTIONMENT UPDATE

The Reapportionment committee appointed by the City Council to determine the new boundary lines for city wards has finished its review. It has issued three proposed maps and held four meetings in late January for public input into the process.

The City has also created a survey through which the public can provide input on the process. The survey will be open through February 6 and can be found using the following link: https://www.surveymonkey.com/r/wardreapportionment. When taking the survey,

participants will be shown the three proposed maps and the population changes and can choose their preferred configuration. The Committee will present its final report to City Council by February 15, 2022.

The LWV has asked the Reapportionment Committee for a verbal explanation to accompany these maps so citizens can understand which neighborhoods are affected.

REDISTRICTING IN MISSOURI UPDATE

What have we learned:

- · Redistricting is a very political process.
- Redistricting is disorganized.
- Redistricting is frustrating.
- Redistricting is challenging, especially drawing a fair map.
- Redistricting is tedious.

But:

- Redistricting is required every ten years, with each new census count.
- Redistricting is essential to give a voice to the citizens of the state.
- Redistricting and drawing fair maps is possible.
- Redistricting has changed with the new tools available.
- Redistricting should be conducted differently in the future.

Missouri House Map

The House Bipartisan Independent Commission members approved a map on January 19. Their approved map will be sent to the Secretary of State's office and used for the next ten years. Here is a link to the map: https://bit.ly/3s9QoGf

Missouri Senate Map

The Senate Bipartisan Independent Commission members met on December 23 and agreed to disagree. In other words, they decided their work was over because they could not agree on their next step. So they ceased trying to reach an agreement on the Senate map and disbanded. The map for Missouri Senate seats will now be decided by a judicial panel of six people.

MO US Congressional Map

The Congressional District map is created using a process similar to the enacting of a Missouri state bill. A redrawn U.S. Congressional map cleared the Missouri House by a vote of 86 to 67, but without an emergency clause needed for it to go into effect before the August 2 primary. The House map maintains the current partisan balance of the state's Congressional delegation: six Republican seats and two Democratic seats.

The Senate Select Committee on Redistricting voted to approve the bill January 25 and sent it to the Senate for action.

The decennial (once per decade) redistricting process is on a tight timeline after delays in U.S. Census data due to the pandemic, as well as Gov. Parson's decision not to call a special session last year devoted to redrawing Congressional maps. Without an emergency clause, the map will take effect on August 28. Future

The LWVMO Fair Redistricting Committee will follow the drawing of the Senate map and the Congressional District maps and conclude their work with a debriefing and documentation for future use.


