The Fate of PACE?

Will Governor Nixon sign the legislation that includes PACE (Property Assessed Clean Energy)?

Advocates for the program are urging him to sign the bill that allows cities to set up local Clean Energy Development Boards to finance the cost of energy retrofits and renewable energy systems for home and business owners. Property owners repay the loan over 20 years through a special assessment attached to their property taxes; upon sale the loan obligation and the energy savings transfer to the next owner. PACE financing benefits homeowners by paying for the cost of energy improvements; cities benefit from new job creation, property upgrades and a lower carbon footprint.

As you can tell from the rest of this issue of the *Voter*, the national convention of the League of Women Voters recently concluded in Atlanta. Four of our local members were able to participate and the state as a whole had about 16 Leaguers in attendance from five different local leagues and the state board. A good showing! This was the first national convention for me (as well as for Dick Parker, our other local delegate) and I was impressed with the dedication and energy from those in attendance (there were sessions from 7:30 a.m. until 10:00 p.m. every day!). Even more relevant was the breadth and depth of the knowledge evident among delegates as well as the passion with which problems were addressed. I believe all of us returned with many ideas.

I was also struck, however, with the diversity among the delegates particularly in age and orientation. Not unlike the movie, *Iron Jawed Angels*, there was almost always a "negotiation" between those who wanted to be more confrontational and those who wanted to be more politick. Although such discussions were not always comfortable, the give-and-take is, I believe, critical to the success of both the League and its (our) issues.

The delegates addressed many important issues, at least some of which are demonstrated in the studies, concurrences and resolutions approved which are listed later in this issue. Although you may find some to be controversial, all were thoroughly discussed by the delegates before being voted upon. There was not sufficient space in this issue to give you the details on some of the issues, but many will appear in coming issues.

Most immediately, two national studies were approved and we will need your help in establishing the study committees, doing the background research (with the help of LWVUS), discussing the issues and coming to consensus in the coming months. Watch for the information.

Two Studies Approved at the 2010 LWVUS Convention!

Education:

The study would focus on the role of the federal government in education policymaking, with possible consideration of funding, common standards and/or governance relationships among all levels of government. The scope will be dependent on available resources, including committee and LWVUS staff time.

Privatization (LWV of Seattle, Washington):

A study of privatization of public services to include: (1) What services do we, as citizens expect our government to provide us; (2) The philosophical basis for privatization; (3) An examination of how privatization works in terms of cost, oversight, (to include transparency), efficiency and observation of ethical and legal standards in safety, labor management, environmental issues, etc.; and (4) An evaluation of quasi-public institutions such as the USPS, Fannie Mae, Freddie Mac, private military contractors.

In the coming months, the national board will solicit applications from members interested in working on these two study committees and those committees will determine the final scope of each study and reporting timelines. Look for our own local League announcements on joining one of the study steering committees.

National Program 2010-2012

Under Article XII, Section 2 of the LWUVS Bylaws, convention delegates can concur with a position statement at convention, provided that the concurrence is passed by a two-thirds majority and provided that notice is given six weeks before convention and that the concurrence statement is supported by pro and conmaterial and an explanation of the rationale for using this form of member of agreement. Historically, concur-



rence at convention has been based on position statements arrived at after study and consensus in one or more states, but the bylaws do not limit concurrences in that manner. The following concurrences were approved:

<u>Arms Control</u> (LWVUS Board recommendation): To amend and update the Arms Control position based on the review and recommendation of the LWV Arms Control Task Force

Marriage Equality (LWV of Saratoga County, NY): To be added to the Quality of Opportunity position, based on studies by LWV of Maryland and LWV of Maine: The League of Women Voters of the United States supports equal rights for all under state and federal law. LWVUS supports legislation to equalize the legal rights, obligations, and benefits available to samegender couples with those available to heterosexual couples. LWVUS supports legislation to permit same-gender couples to marry under civil law. The League believes that the civil status of marriage is already clearly distinguished from the religious institution of marriage and that religious rights will be preserved.

<u>National Popular Vote Compact</u> (LWV of Arizona): To add the following words as the third sentence to the LWVUS position on selection of the president: "We support the use of the National Popular Vote Compact as one acceptable way to achieve the goal of the direct popular vote for election of the president until the abolition of the Electoral College is accomplished."

All other current LWVUS positions were retained in the areas of Representative Government, International Relations, Natural Resources, and Social Policy.

Resolutions Approved at the 2010 LWVUS Convention



<u>Cuba</u> (LWV of Florida): Be it therefore resolved that we, the representatives at the 2010 National Convention of the League of Women Voters, call upon the Board to use the resources of the League to support and lobby to lift the travel ban to Cuba."

Safe Drilling and Mining (LWV of Tompkins County, New York): Be it therefore resolved that we, the representatives at the 2010 National Convention of the League of Women Voters, call upon the Board to use the resources of the League to support and lobby for significant strengthening of appropriate regulation, oversight, inspection, and penalties associated with the development of fossil fuel resources. This strengthening should include elimination from national legislation of the exemptions for drilling and mining, as well as



additional legislation requiring the federal agencies to regulate drilling and mining in a manner consistent with the preservation of a healthy environment. We also call on the Board to communicate with the President and the Congress putting them on notice that Leagues across the country are deeply concerned about this issue.

<u>Filibuster</u> (LWV of Kalamazoo Area, Michigan): Be it resolved that the League of Women Voters call upon the Senate to change its rules to limit the use of the filibuster.

SARA Resolution LWV of Monterey Peninsula, California): Be it resolved that the LWVUS add the principle of Transparency to the SARA Resolution, as adopted at the 2004 LWVUS Convention and amended at the 2006 LWVUS Convention, so that the following principles are included: Security, Accuracy, Recountability, Accessibility and Transparency. (This relates to electronic voting.)

Health Care (LWV of Bloomington-Monroe County, Indiana): Be it resolved that we, the representatives of local and state Leagues assembled at the 2010 LWVUS Convention, call upon the LWVUS Board to advocate strongly for bills that legislate for improved Medicare for all.



Gulf of New Mexico (LWV of Dane County, Wisconsin and LWV of Alabama): We request that LWVUS highlight the need for those responsible for the oil spill to be held accountable. Further, the LWVUS demands that our government hold those responsible for the environmental disaster accountable for the clean-up. The LWVUS further urges the legislative



and executive branches of the federal government to immediately take all necessary steps to maximize to the extent practicable the ability and efforts of all relevant federal agencies and departments to take action, and to work with the U.S. coastal states and communities most directly and immediately affected to respond creatively, efficiently and effectively to the environmental, health, and economic crisis created by the oil flowing from the out of control BP oil well in the Gulf of Mexico and by the efforts to contain and disperse it.

Advancing Renewables in the Midwest

Member Reports from the Convention

Dick Parker: I attended the Great Lakes Water issues meeting and felt that little of it applied to the rest of us. Their major current issue seemed to be storm water causing sewage overflows. That has been a well documented problem for more than 40 years and is very expensive to fix. The other problems which were briefly touched on are also old problems.

The Redistricting caucus suggested that each state might be interested in using a computer program which is being developed to permit non-governmental groups to suggest redistricting plans. Someone in our League might be interested in following up on this since redistricting will also take place at the city government level. I have considerable information if anyone is interested.

(Editor's Note: Dick was one of our League's official delegates to the convention. He also worked with other delegates from other Leagues to try to get a study adopted for a Department of Peace. Although it did not succeed this time, he is continuing the effort.)

Elaine Blodgett: The Atlanta, GA League convention was as interesting as anyone I have attended. Given the really hot weather, 98 degrees in Atlanta, it was good to be indoors and all on one level. And, the drive down and back with Mary Merritt, Kathleen Boswell, and Lois Detrick provided great conversation and interesting ideas despite highway backups, storms and lightning.

About 700+ people attended as lots of ideas were submitted and many actually came to fruition as Linda gives in her report. As a candidate on the national ballot who was brand new, I served at the microphone with local Georgia volunteers as a parliamentary aide, and had to pay close attention to the process. It became important also to see what if anything would happen if there were candidates nominated from the floor and how the the whole nominating process went. It's great to be representing Columbia, Missouri.

Dick made a wonderful presentation on the Peace Department, and I was thrilled that Columbia Boone County had a study to present. At the end, even though we were all ready to leave, there were about 52 people at the microphones with advice or questions for LWVUS, and every single person got to speak and express their thoughts. Also, the guilt that was raffled off for Missouri league went to someone in Georgia and it will forever have a guilt square done by our own league member, Marge Hicks.

(Editor's Note: Elaine was elected as the LWVUS Nominating Committee Chair for 2010-12 at the convention. Currently, she is also that Missouri state coordinator for the Membership Recruitment Initiative.)

Press Release, June 14, 2010: Today, Flag Day, the League of Women Voters of the U.S. (LWVUS) and the League of Women Voters of Arizona (LWVAZ) announced strong opposition to the immigration measure recently passed by the Arizona legislature and signed by the governor that could cause law enforcement offi-LEACH FOR COMEN VOTUSES cials to target racial and ethnic minorities unfairly.

"The struggle for fairness and equality has been long and hard; it is very disappointing when a state legislature and governor turn their backs on fundamental civil rights," said national League president Mary Wilson. "The inevitable result of this law is that 'equal justice under law' will be undermined," she said.

LWVL

Whenever an officer stops, detains or arrests an individual in Arizona, the new law requires the officer to check a person's legal status if the officer has a "reasonable suspicion" that the detained person is illegal. However, the law is vague about what constitutes what "reasonable suspicion," raising the concern about fair and equal enforcement.

Bonnie Saunders, president of LWVAZ said: "On the surface, many of the elements of this law might seem reasonable, but taken as a whole, the law undermines the basic values that we stand for in Arizona."

"Today, as we celebrate Flag Day, the League of Women Voters celebrates the American dream – the dream that every person will receive equal justice under law," the two presidents said. "Arizona needs to change its law to make it conform to fundamental American values," they concluded.


(Note: The League of Women Voters of Arizona and the League of Women Voters of the U.S. joined a lawsuit challenging the recently-enacted SB 1070 in Arizona, purported to be an attempt to curb illegal immigration, that "will subject United States citizens and legal residents who are members of racial and ethnic minority groups, and particularly those who may be perceived to be somehow 'foreign,' to the disruption, stress, and humiliation of detention and interrogation." 
The additional money brought in by our fundraisers supplements our dues and is essential to keeping us solvent.
