PRIMARY CANDIDATE FORUM ON JULY 22 BALLOT ISSUES FORUM ON JULY 24



Candidates in the August primary races will be featured in a Tuesday, July 22 forum in the Friends Room at the library at 6:30 p.m., with refreshments at 6:00 p.m.

The candidates include: Republican candidates for 47th District State Representative- Chuck Basye and Betsy Phillips; Democratic candidates for Boone County Recorder of Deeds- Nora Dietzel and Lois Miller; and candidates for Division 5 Associate Judge-Republicans Michael Whitworth and Doug Shull, and Democrats Rob Fleming, Finley Gibbs and Kim Shaw. KFRU's David Lile will moderate the forum and it will broadcast live on KFRU radio.

Five Constitutional Amendments will be on the August 5th ballot. Our Ballot Issues Forum will be Thursday, July 24th, in the Friends Room at the library at 6:30 p.m., with refreshments at 6:00 p.m.

Ballot language isn't available yet, but the issues will include a transportation sales tax, guaranteed rights of farmers and ranchers, a new lottery ticket to benefit veterans' homes, electronic privacy, and declaring the right to keep and bear arms as unalienable. The ballot will also include a county 1/8 cent sales tax issue for the fairgrounds. We will try to find pro and con speakers on all issues. If we cannot find speakers, we will try to provide pro and con information.

Candidate and ballot issue forums for the November general election will be held in

October. The Republican winner in the 47th District State Representative will face Democrat John Wright.

A Republican candidate for Boone County Recorder, Wes Upchurch was recently disqualified and the Republican Central Committee has until June 10 to name a replacement. If one is named, the Democratic winner will face that candidate. The Republican and Democratic winners for Division 5 Associate Judge will face each other. The other races will be the 44th State Representative District, with Democrat Tom Pauley against Republican Caleb Rowden; Boone County Presiding Commissioner, with Democrat Dan Atwill against Republican James Pounds; and Boone County Collector, with Democrat Brian McCollum against Republican Cheri Toalson Reisch.

Unopposed candidates will not be included in our forum. Running unopposed for the state legislature are Democrat Kip Kendrick for 45th District; Democrat Stephen Webber for 46th District; and Republican Caleb Jones for 50th District. A number of county candidates are also unopposed.

The state issues on the November ballot include early voting, allowing lawmakers to override gubernatorial budget cuts, and permitting evidence about prior criminal acts to be used against people facing prosecution for child sex offenses.

OUR HISTORY SERIES #21: THE EQUAL RIGHTS AMENDMENT

The Equal Rights Amendment (ERA) was originally written by Alice Paul, the suffragist leader and founder of the National Woman's Party, in 1923, as "the next step in confirming equal justice under law for all citizens". It was introduced into every Congress between 1923 and 1972. Finally passed in 1972 by Congress, it needed to be ratified by 38 states. The

process came up short by three states within the original sevenyear time limit for ratification, which was later extended to 1982. As many of our members might recall, Missouri was one of the states that did not ratify the Amendment.

Looking back at the history of the League of the 1920's and 1930's, it would seem that support for an Equal Rights Amendment would have been a "no brainer" for the early members of the League of Women Voters.

The text of the Amendment at that time: "Men and women shall have equal rights throughout the United States and every place subject to its jurisdiction."

However, as hard as it is to believe, at that time, the national League of Women Voters opposed the measure. According to the LWVUS publication Impact on Issues (2012-2014), the League delegates in 1921 "decided that an ERA might adversely affect new and hard-won state labor legislation which offered some protection to tens of thousands of women working in nonunionized, unskilled jobs." They also "wanted to affirm strongly that its interests and lobbying activities were not confined to women's issues."

In a local newspaper article from Columbia (article is undated, but probably from the 1930's), our own Luella St. Clair Moss reported on hearings in Congress where Dorothy Straus. a national representative for the League, spoke against the Amendment, stating that "the whole condition of the country would become chaotic ... it would result in legal and technical confusion."

The newspaper article concluded by reminding readers that the "local organization of the League of Women Voters has gone on record as being opposed to the amendment."

The historic information in the LWVUS' Impact on Issues continues the story of the LWV and the ERA. A change of opinion did eventually happen. "As the League became active in the

> civil rights struggle of the 1960's, members grew acutely aware of the parallels between the status of women and minorities." A strong push for women's issues developed at the national level, when, in1972, after the passage of the Equal Rights Amendment in Congress, the national Convention

"overwhelmingly approved support of 'equal rights for all regardless of sex'.

As noted above, the efforts at ratification seemed to end in 1982. But did you know that the struggle for ratification by three states, called "The Three State Solution", continues today? A number of women's groups in Missouri, including the AAUW and the Missouri State Women's Political Caucus worked on having the ERA passed by the Missouri Legislature. It was under consideration in the Missouri House and Senate this year, but unfortunately there was no action taken.

In information provided by the Missouri Equal Rights Amendment Campaign, one of the statements in support of passage states the following:

"The fact that a simple statement of equality is still so controversial proves its necessity."

HELP ADD VIRGINIA MINOR TO THE HALL OF FAMOUS MISSOURIANS

Virginia Minor led the fight for women's suffrage in Missouri. In 1872, she led hundreds of women in an effort to get women the right to vote under the 14th Amendment. With her husband as her lawyer she sued. But the Supreme Court in Minor v. Happersett decided that women were not covered



by the 14th Amendment's guarantee of equal citizenship for all Americans. Not until 1971, nearly 100 years later, did the Court finally apply the 14th Amendment to women. After losing the case, she studied law and continued her work for women's suffrage until her death in 1894.

The nomination of Virginia Minor to be added to the Hall of Famous Missourians at the Capitol has been won, but the funds to pay for the sculpture must come from private sources. It will cost \$10.000.

MAY FORUM COVERED MENTAL HEALTH SERVICES FOR CHILDREN

"What's Happening in Mental Health Services for Children and Youth" was the topic of a well-attended forum on Tuesday, May 20, 2014 in the Friends Room at the Columbia Public Library.

In November of 2012, Boone County voters approved a quarter-cent sales tax to fund mental health services for children. The Putting Kids First Coalition, represented by Christine Corcoran, led the drive to get the issue on the ballot and continues to work to increase public awareness of this issue. Kelly Wallis spoke for the Boone County Children's Services Board, which is working to develop procedures for distributing the estimated \$6.5 million that will be generated annually by the tax.

Susan Perkins, Columbia Public Schools
Coordinator of Elementary Guidance and
Counseling, explained the comprehensive
guidance program used in the Columbia
schools. Dr. Melissa Armstrong, of the
Thompson Center for Autism and
Neurological Disorders, described the
services provided by that organization.
Attorney Tim Harlan, President of Missouri
Chapter of the National Alliance on Mental
Illness emphasized the importance of training
teachers to recognize signs of mental health
traumas.

In recognition of May as Mental Health Month, this event was intended to raise awareness of mental health issues. It was co-sponsored by the League of Women Voters of Columbia-Boone County and the Columbia Public Library.
