PRESIDENT'S MESSAGE

Happy New Year to all! I think that the overriding message this month is that we hope the new year will bring better tidings than the previous one! Now that vaccines are on the way, there is certainly great hope in the land.

Since the pandemic really didn't slow us down last year, we don't expect to slow down this year either.

There will be efforts in the area of legislation at both the national and local levels to make voting free, fair and accessible to citizens. We will also be closely watching the redistricting process in Missouri. Please take note of Sharon Schneeberger's article on the process on page 4. We are very proud that Sharon will be taking a leadership role in the state LWV on this issue.

Here are two ways you can take action right now!

(1) For the People Act (HR 1)

The national League is calling on President-Elect Joe Biden and the next Congress to act on democracy reforms early in 2021. LWVUS has called for national advocacy on HR1 and HR4, both of which relate to free, fair and accessible elections and voters' rights.

The House passed the For the People Act (HR 1) in March 2019. This comprehensive bill would transform our political system into one that is more inclusive, responsive, and representative of the American people. Its reforms would:

- Expand and protect voting rights and access to the ballot;
- Put ordinary Americans ahead of Big Money donors;
- End gerrymandering so that electoral districts are fairly drawn; and
- Clean up government and hold elected officials to the highest ethical standards.

The Voting Rights Advancement Act (HR 4) passed the U.S. House on Dec. 6, 2019. The bill would restore parts of the 1965 Voting Rights Act that the Supreme Court eliminated in Shelby County vs. Holder (2013). States would again have to receive pre-approval from the Department of Justice or the U.S. District Court for the District of Columbia before making legal changes to their voting practices.

(2) Seeking Safe Voting in Missouri

Voters should be able to cast a ballot in 2021 without fear of getting or spreading COVID-19. Provisions to allow absentee voting for those who have or are at high risk of COVID-19 and provide remote voting options for Missouri voters expired on Dec. 31, 2020.

If you haven't already done so, I encourage you to urge Governor Mike Parson to extend safe voting provisions to ensure that all Missourians can safely cast ballots during the 2021 municipal elections. Sign the Missouri Voter Protection Coalition's petition Tell Gov. Parson to Extend COVID Voting Provisions - Action Network

State Program Planning

Every two years the state LWV holds its biennial Convention, and this year's convention is planned for Saturday, May 15, 2020 on Zoom. ISSUES AND ACTION: LWVMO PROGRAM PLANNING ON JAN. 27

In preparation for the May 15, 2021 LWVMO State Convention, local Leagues will participate in LWVMO Program Planning. This process is an important League tool for identifying issues of concern and for evaluating the current positions in the Guide to State Action 2019-2021.

The Guide contains the public policy positions adopted by LWVMO that pertain to statewide issues. The Guide also includes the "Statement of Principles of the League of Women Voters" adopted by the national convention. The Principles and positions are used by the state and local Leagues when they take action on issues in local communities, the state legislature and other advocacy activities.

A local League is not allowed to take action as a League entity on issues that are not addressed by a position either at the local, state or national level. So, this process is the life blood of the League!

The Columbia League will hold our LWVMO State

FORUM ON MINORITY YOUTH AND THE JUVENILE JUSTICE SYSTEM

Planning is underway for a two-part forum about Minority Youth and the Juvenile Justice System which will be held on two Wednesdays, Feb. 3 and Feb. 17, at 7:00 p.m. on Zoom.

A subcommittee of the LWV Civil Liberties Committee and several cosponsors, including the Columbia Public Library, the NAACP, the Alpha Kappa Alpha, Inc. - Delta Tau Chapter Sorority, the Boone County Children Services Board, the Minority Men's Network, and the Mid-Missouri Civil Liberties Association are working on arranging the forums.

The national LWV supported a position at the 2020 Convention to advocate against systemic racism in the justice system and asked members to advocate within every level of government to eradicate systemic racism.

In response, Janet Thompson proposed the idea for this public forum. Many people have heard the term "School to Prison Pipeline" but may not be sure what that really means. The first forum will provide background for the subject. We are

asking experts to present data to clarify the problem and to discuss the nature of systemic racism and implicit bias.

The second session will address what has been working and how to make individual and collective impact to reach the goal of every child succeeding. A number of important local organizations will be highlighted at this event.

A related learning opportunity will be the Lunch & Learn program on Tuesday, February 9, which will encourage viewers to participate in the United Way "Equity Challenge." The Challenge is a seven-week series with exercises and resources to help citizens learn how to transition from being an ally to being a leader in the fight for equity. REDISTRICTING IN MISSOURI

What is redistricting?

By federal law, redistricting — the process of redrawing district boundaries to guarantee equal voter representation — occurs following the census (every 10 years). New districts must be drawn on the basis of the population in the state and governments must redraw districts so districts have equal populations. It is not expected that Missouri will have gained population, but the population may be distributed differently than it has been in the past. We will know the census numbers when they are delivered to the state, as close as possible to April 1.

Why do we care about redistricting?

We all expect representation from our elected officials: we want all citizens to vote because every vote matters. When maps are unfairly drawn, citizens do not have fair representation. When maps are not fairly drawn it is called gerrymandering (https://tinyurl.com/ycxlvmw2) and it does happen. Gerrymandering is the practice of drawing district boundaries to achieve political advantage for certain legislators and/or for a particular political party. It involves the manipulation of district boundaries to either leave out or include specific populations in a particular district in an effort to ensure a legislator's reelection or to advantage one party. In relation to gerrymandering you may hear words like "packing" and "cracking" used. Both political parties do gerrymandering.

What do we know about redistricting in Missouri?

Currently the state has 8 US Congressional districts, 163 Missouri House districts, and 34 Missouri Senate districts. (US Congressional districts may also change, depending on the population numbers from the 2020 census data.)

With the passage of Amendment 3 (see complete bill, Senate joint resolution 38, (https://www.senate.mo.gov/20info/pdf-bill/tat/SJR38.pdf) here is what we know.

Under Amendment 3:

 The nonpartisan state demographer was eliminated. A bipartisan commission appointed by the governor will draw the maps. The Amendment creates two commissions:

- A House Independent Bipartisan
 Citizens Commission of 20 people
 consisting of an equal number of
 Republicans and Democrats nominated
 by party officials, and
- A Senate Independent Bipartisan
 Citizens Commission of 20 people
 consisting of an equal number of
 Republicans and Democrats nominated
 by party officials.
- Approving the new map will require a 70% commission vote (14 out of the 20 members must agree on a final redistricting plan) by each of the commissions.
- If a commission cannot agree on a map, this activates a back-up redistricting panel of 6 Missouri Court of Appeals judges who take over establishing the maps for redistricting in the state.
- The criteria of population, voter rights abridgment, contiguous districts, simple shapes, and the rules for county boundaries must be considered with a higher priority than the criteria of competitiveness and partisan fairness.
- The population criterion make it possible to NOT count children and non-citizens in the redistricting plan. (We do not know how the redistricting commissions will implement this criterion, nor if it will stand up to a court challenge.)

What can LWV members do?

We know that defining fair maps may not only be extremely difficult, but, also, simply unrealistic. But League members can urge their political leaders to establish a PACT.

P-people over politics in carrying out the redistricting process.

A-accountability of those involved in making the maps.

C-compromise in making decisions about the goals.

T-transparency in each step of the process. (Cont'd on pg. 5)

2021 LEGISLATIVE ALERTS

The Missouri State Legislature will convene on January 6 and the 117th Session of the U.S. Congress will convene on January 3rd. LWVMO will be sending out weekly legislative alerts on legislation of interest to League members. And our local League will send out alerts when we get them from LWVUS. Calling, writing emails and setting up in person meetings is a way to educate legislators on the consequences of legislation and to encourage them to introduce or support legislation. LWVMO does not have the finances to afford a lobbyist, so we rely on partners (e.g. Missouri National Education Association) to help us with analysis of legislative activities. Nancy Copenhaver, a former state rep, and Marilyn McLeod have been preparing the weekly state legislative updates.
