# SEPTEMBER 14 LUNCH & LEARN: REDISTRICTING IN MISSOURI

Our Lunch & Learn Program at noon on September 14 will be on Redistricting in Missouri. This is our annual Holly Burgess Public Policy Forum, co-sponsored by the American Association of University Women - Columbia Branch and the Columbia Public Library. Speakers will include Sharon Schneeberger, Chair of the Missouri Fair Redistricting committee and LWVCBC Board Member.

Redistricting is going on in Missouri now. Did you know the Redistricting process occurs once every ten years and is different in each state? We will explain the Missouri Redistricting process (as defined in the state constitution and Amendment 3) and update you on what is currently happening in Missouri. All citizens are

urged to stay informed and to call for transparency, bipartisanship, and public input so this process will yield fair maps. Please attend via Zoom to learn more about redistricting and what actions you might take. Viewers are welcome to pose questions in the Zoom Chat.

On Tuesday, October 12, the Children's Grove will present a program on Suicide Prevention.

The great news this month is that the Missouri Supreme Court unanimously upheld the will and intentions of Missouri voters for Medicaid Expansion. Missourians across the state will now finally be able to realize the health and economic benefits of Medicaid. The LWVCBC has worked diligently for several years to promote Medicaid expansion in Missouri. The Supreme Court Case was issued July 22, 2021, Opinion No. SC99185.

Sharon Schneeberger, Chair of our Fair Redistricting Committee, will speak at our September 14 Lunch & Learn program on Redistricting and how you can help. This is so crucial to democracy and meaningful voting. People Powered Fair Maps, is a LWVUS national redistricting program.

LWVMO, LWVMetro St.Louis, LWVKC and LWVCBC met on Zoom this month to discuss a campaign to thank and highlight poll workers for their work and to educate the public about poll workers. Who are they? They are our neighbors, aunts, uncles, nieces, grandmothers, and daughters.

#### **Poll Worker Information:**

Each year, up to 600 poll workers volunteer across Boone County. Poll workers are a vital part of Election Day and help ensure that every election runs smoothly. Workers set up and manage polling places, assist voters, and maintain the efficiency and integrity of the election process in Boone County.

#### Qualifications:

- 18 years old or older
- · Registered Boone County voter
- Able to read, write, and speak English fluently
- Completion of mandatory training before each election
- Compensation:
- Poll workers are paid a base rate of \$160 per election
- Additional pay is available for added responsibilities and completed trainings.

#### Hours:

Polls are open on Election Day from 6:00 a.m. to 7:00 p.m. Poll workers report to their assigned poll at 4:30 a.m. and leave the poll after completing all duties after the polls close at 7:00 p.m.

### NEW STUDY GROUP FORMING: MISSOURI STATE PREEMPTION OF LOCAL CONTROL

An important new study group is forming, and you are invited to join. In response to local community wants and needs, cities and counties have passed regulations stricter than state law on a wide variety of issues. In recent years the Missouri state legislature has preempted local authority in several areas: limiting local control over the siting of and effluent from Confined Animal Feeding Operations, minimum wage increases, earnings taxes, use/disposal of plastic shopping bags, and local restrictions on firearms. New laws passed in 2021 prohibit local law enforcement officers from enforcing federal gun laws and restrict local government authority to implement public health epidemic control measures.

According to the National League of Cities, "Preemption is the use of state law to nullify a municipal ordinance or authority." Their website notes that "State preemption can span virtually all policy areas."

The preemption of local governmental authority, which is accelerating in Missouri, can seriously impact many LWVMO program positions. In response, the LWVCBC is forming a study group to consider developing a program position and action plan. ## SUMMER OF ACTION: FOR THE PEOPLE ACT & JOHN R. LEWIS VOTING RIGHTS ACT


We're into a Summer of Action to advocate for passage of the For the People Act (HR1) and the John R. Lewis Act Voting Rights Act (HR4/S1) in the U.S. Senate. Voter protection advocates must educate the public that these bills are crucial to ensure that all voters can vote.

So far, in 2021, 22 voter suppression laws have been passed in 14 states. The SCOTUS' Brnovich decision, which ruled against the

"disparate effect" of Arizona's voting laws, will make it harder to win in court actions.

To most effectively counter voter suppression, we need to advocate for the For the People Act and John R. Lewis Act in the public arena. Congressional advocates are working the process internally, and voting rights advocates must tell the public why we need the For the People Act. Both bills will come to a vote in the Senate, and public pressure is required to get their passage.

League members can write letters to the editor, send emails to their friends and family, and post social media notices about how vital the



passage of these two bills is to ensure that each of us has access to voting.

Vigils were held in four cities in Missouri, including Jefferson City, and nationwide, on Saturday, July 17, to mark the anniversary of John R. Lewis' death.

Help the cause by calling 1-888-453-3211 to be forwarded to the offices of Senators Hawley and Blunt to ask them to vote for the For the People Act and the John R. Lewis Voting Rights Act.



# ELECTRICITY PRODUCTION PLANS & GREENHOUSE GAS PRODUCTION

The city has contracted with energy consultant Siemens to provide an Integrated Resource and Master Plan for Columbia's electric power. Siemens will deliver their draft final report to the Electric Integrated Resource and Master Plan task force on August 26. Siemens has been sending portions of the study to the task force for almost two years. There are two major sections: (1) electricity sources, and (2) transmission and distribution (T&D). The draft report on the T&D portion has been delivered. A public meeting to hear the public's views on the entire report will likely occur in October.

Siemens has developed nine case scenarios that achieve 100% renewable energy by 2030 or 2040 or 2050. We recently received numbers for greenhouse gas production for these nine scenarios. The three scenarios most likely to be considered by the City Council are below.



The 2020 - 2023 blue band indicates the period prior to the completion of contracted renewable energy currently under construction, while we are still primarily using coal-fired electricity. The thin red band shows the reduction of greenhouse gas (GHG) as renewable energy is deployed by the 2030 deadline. The green band shows the decrease in GHG by the 2040 deadline. All Siemens numbers stop at 2040. After that (the purple band) is my educated guess. I felt it was important to recognize that the 2050 scenario would still produce GHG after 2040.



### MARIJUANA IN MISSOURI STUDY GROUP UPDATE

The LWVCBC Marijuana Policy Study Committee held its second meeting on June 26. We reviewed the materials recommended by members of the committee.

We also reviewed the recent dramatic progress in marijuana law reform. Six states have legalized marijuana through the legislative process since the beginning of this year.

Last week, a bill was introduced in the United States Senate by Democratic Majority Leader Charles Schumer. This bill would repeal the federal prohibition on cannabis and set up a federal system of taxation and regulation.

Our goal is to produce a final report no later than January of 2022.
