MARCH 21 & 23: CANDIDATE/BALLOT ISSUE FORUMS

The LWV has scheduled two Candidate/Ballot Issue forums for the April elections. The Monday, March 21st forum will feature Columbia School Board candidates Paul Rainsberger, James Whitt, Sarah Dubbert, Joseph Toepke, and Jan Mees. The five candidates are competing for two seats. Dr. Peter Stiepleman, Superintendent of the Columbia Public Schools, will speak in favor of the Columbia Public Schools ballot issues for a 65-cent school levy increase and the no-tax-increase bond issue. If there is organized opposition we will invite a representative.

The Wednesday, March 23rd forum will feature Columbia City Council and mayoral candidates. If

there are any Columbia ballot issues, we will feature those at this forum. Third Ward candidates are Karl Skala and Tom Leuther. Fourth Ward candidates are lan Thomas and Daryl Dudley. Mayoral candidates are Skip Walther and Brian Treece.

All candidates in both forums have confirmed that they will participate. Both forums will begin at 6:30 p.m. (refreshments at 6:00 p.m.) in the Friends Room at the Columbia Public Library, which is cosponsoring the forums with us. KFRU will broadcast both forums live and the *Columbia Daily Tribune* will do a live webcast of the events.

ACTION! ACTION! ACTION! PROGRAM PLANNING REPORT

The LWVUS is asking local Leagues to support ACTION for 2016-2018, instead of any additional studies. At our National Program Planning meeting we learned about the LWVUS Board suggestion to support a campaign called Making Democracy Work. The Board is also asking that local Leagues concur with a broad, general statement on redistricting that will allow states without redistricting positions to take action at the state and local level.

The Making Democracy Work campaign will focus on three key issues: Money in Politics; Voting Rights and Voter Protection; and Redistricting. Our

League members voted to also include climate change in that campaign.

Additional information about the legislative priorities that will be addressed by the LWVUS this year is provided in the related article on the next page.

After input from local Leagues across the country, the LWVUS will put forward final proposals at the LWVUS National Convention in June to be voted on by the convention delegates.

OUTLINING THE LEAGUE'S PRIORITY FEDERAL ISSUES FOR 2016

The League of Women Voters has the opportunity to play an active role on many priority issues in 2016. In addition to lobbying the 114th Congress in support of League priorities, we are working on a number of important policy proposals put forth by the President and agencies of the federal government. We will also be participating in litigation that could have a major impact on laws and regulations supported by the League.

Here's a sample of some of the important work the League will be focused on in 2016:

Voting and Elections: Restoring the Voting Rights Act (VRA) continues to be a top priority for the League. It's now been nearly three years since the U.S. Supreme Court gutted key provisions of the VRA and Congress has failed to act on historic legislation to restore the voting rights of Americans across the country. The League will continue to lobby House and Senate leadership, and engage grassroots support, to ensure that legislation to restore the VRA gets hearings and a vote in both houses of Congress.

In the area of voter registration, LWVUS has called on the Obama Administration to comply with the National Voter Registration Act (NVRA) when applicants apply for health insurance through the federal health exchanges under the Affordable Care Act (ACA). The League believes the exchanges are public assistance agencies and therefore must provide voter registration opportunities to all applicants, similarly to other social services such as the Department of Motor Vehicles or Medicaid enrollment. Some states, like California, that offer state-run health exchanges under the Affordable Care Act have begun to offer voter registration opportunities following pressure from the League. We believe proper implementation of the NVRA at the health benefit exchanges is an incredible opportunity to help every eligible American citizen participate and contribute to our democracy.

Money in Elections: As we enter a Presidential election year, billions of dollars are flooding into our political system and yet, voters still have no idea where the money is coming from. The

League continues to push Congress to move the DISCLOSE Act to the forefront. We also continue to address disclosure and independent expenditures with the Federal Election Commission (FEC). The League hopes to build on our success of sending nearly 30,000 comments to the FEC encouraging them to redefine these two terms and end corruption in politics.

Climate Change: Now that the Environmental Protection Agency (EPA) has finalized the Clean Power Plan, the historic regulations to limit carbon pollution from power plants, the implementation of these regulations heads to the states. State officials and legislatures must now follow the common sense building blocks developed by the EPA to meet the goals established in the plan. Leagues across the country are working to build support for, and promote compliance with, the Clean Power Plan.

Redistricting: Late last year, the U.S. Supreme Court heard arguments in Evenwel v. Abbott, a major case that could forever change the way we view the political map. Evenwel has the potential to upset the criteria for drawing state and local legislative districts so that districts would be determined by the total number of voters instead of total population. The League submitted an amicus brief in Evenwel that supports the current practice of drawing district lines based on population counts. Leagues around the country are also involved in their own redistricting processes. The League of Women Voters of Ohio helped pass a major ballot initiative to amend the state constitution and change how the lines are drawn in Ohio's state legislative districts (PDF).

2016 promises to be a busy year. Across the country, state and local Leagues will continue to lead the way to fight back against bad voter reforms and initiatives as well as for pro-voter reforms in their own legislatures. At the federal, state and local levels, Leagues will be working hard to influence public policy and encourage participation in government on these key issues and more.

OBAMACARE: THE GOOD THE BAD AND THE UGLY A REPORT ON THE FEBRUARY LUNCH & LEARN PRESENTATION

On February 16 we were fortunate to host Dr. Jack Colwill's talk entitled "Obamacare: The good. the bad, the ugly. Future hope?" His Lunch & Learn presentation was a condensed version of a talk he gives to MU medical students, and it was packed with thought-provoking content. Dr. Colwill, Professor Emeritus of Family & Community Medicine, UM School of Medicine, began by saying that when he graduated from medical school in 1957, he believed that universal

health care was coming soon. But that was not to be. Fifty years later, the Affordable Care Act (ACA) created an imperfect system that has delivered some benefits but is failing in many ways. Here are the highlights:

• The Good: The percentage of uninsured people has dropped to around 11%. Applicants cannot be excluded because of preexisting conditions. Preventive services are better covered. Insurance companies must spend 85% of insurance premiums on medical care.

The Bad: There are still an estimated 30 million uninsured.

about half of whom would be eligible if they applied. People whose income is too high for Obamacare may decide not to purchase their own insurance or not to buy into an employeroffered plan. Then they are unable to cover high medical bills, and costs for everyone go up. Others are undocumented immigrants. A study has shown that 53% of the uninsured have trouble paying medical bills, compared with only 19% of those with private insurance. If people choose a plan with high deductibles, in order to lower the cost of monthly

premiums, they may run into trouble. In addition, the biggest increase in health spending is the cost of prescription drugs, particularly specialty drugs, which Obamacare does not address.


• The Ugly: States like Missouri that have not expanded Medicaid eligibility leave many working poor in the situation of being too "wealthy" (even though beneath the federal

poverty level) for Medicaid but unable to afford private insurance on the ACA marketplace. Insurance companies continue to be hugely profitable, and some have opted out of the ACA marketplace. Even worse for the long term, the ACA does not bring medical costs in line.

If health care spending as a percentage of GDP rises even 2% per year, government spending on nonhealth issues will dive over the next century.

How did we get in this "ugly" fix? Dr. Colwill explained that we have a "fee for service" system in which there are incentives to see more patients, do more tests, fill hospital beds, etc. The primary care physician has taken second place to more

expensive specialists, and the primary care physician is often not a gatekeeper to costly specialist care. An audience member asked, "Should we move to a single payer system?" This would be the "Medicare for all" model. Dr. Colwill said there are good aspects of such a system. It would diminish the role of insurance companies and give the insurer (the federal government) more power to control costs of health care and prescriptions.
