#### President's Column

The work of the League has been so apparent to me, but recently the education aspect of it took on a new meaning.

I was reading <u>Dark Star Safari</u> by Paul Theroux, a recounting of the author's journey from Cairo to Cape Town. He was anxious to revisit Malawi where he spent two years teaching school as a Peace Corps volunteer. He was dismayed at finding the school a shambles. One of the present-day teachers was bemoaning the fact that, once the foreign aid was no longer available, the Malawi government did nothing to assist in funding to make education available.

Theroux conjectures that some governments in Africa depended on underdevelopment to survive, as they "needed an uneducated and passive population to keep themselves in office for decades. A great education system in an open society would produce rivals, competitors, and an effective opposition to people who wanted only to cling to power."

Without that education, the society has failed to form and thrive beyond subsistence living. Most people who have managed to get educated in other countries emigrate to those countries where jobs are available that use their skills and knowledge.

I can think of no other descriptor that underscores the necessity of an educated populace. It shines a new light on the importance of our Education study as well as the ongoing need to educate voters about the issues currently facing our communities, state and nation.

Let us not ever lose sight of this important facet of the League. While competition and opposition may be uncomfortable at times, nevertheless it is vitally important to a robust country.

### Recruiting of Members is On-going Effort for State League Members

Recruiting members is what CARRIE is all about. HOWEVER, that involves more that it first appears. Besides always inviting and asking friends to join, it's what you do <u>in</u> your community.

### Numerous Activities Underway in Mexico/Audrain Co.

We were pleased to have the two newest members of the Mexico School Board attend our open meeting to study the role of the government in education. They not only entered in the discussions they asked questions and wanted our opinions.

Our new voter registration is almost completed. We were very happy to have 38 new registrants at the Advanced Technical Center here in Mexico. Several others took their registration card with them to mail independently as they were from other counties.

Our new project is to conduct voter procedure instructions at WIC clinics in Laddonia and Vandalia. We were approached by the Audrain Public Health Unit to conduct these training sessions. Our County Clerk agreed to coach us. New ground and new challenges for us.

Our STD Awareness project is taking off. Presently the 4-H clubs, Boy and Girl Scouts and ministers are being contacted for presentations and material on the situation here. Later the civic organizations, social groups, residential care facilities and the Veteran's home will be included.

For there to be an equivalency, the death penalty would have to punish a criminal who had warned his victim of the date at which he would inflict a horrible death on him and who, from that moment onward, had confined him at his mercy for months.
