
Public Schools; Ruth McClusky, Chief Juvenile Officer, Boone and

APRIL ELECTION CANDIDATE FORUMS ON MARCH 16 AND 23

Due to the large number of candidates for the April 6th Election, the LWV has decided to have two candidate forums. The races are for Columbia City Council Wards 2 and 6, the Columbia School Board, and State Representative District 45. There will not be any ballot issues on the April 6 ballot.

On Tuesday, March 16 we will have the candidates for Columbia City Council Ward 2: Bill Weitkemper, Jim Meyer, and Andrea Waner; and Ward 6: Betsy Peters, Randy Minchew, and Philip Merriman.

On Tuesday, March 23 we will have the candidates for Columbia School Board: Teresa Maledy, Lucas Neal, Aron Saylor, Katherine Sasser, and Jeanne Snodgrass. In addition, we will have candidates for MO State Representative District 45: David Tyson Smith (Democratic) and Glenn Nielsen (Libertarian).

Both forums will be co-hosted by the Columbia Public Library, will be on Zoom, and will begin at 7:00 p.m. We will be using the library's Zoom account, so you must register through their site (we will send out the link to register closer to the forums). EQUAL RIGHTS AMENDMENT UPDATE

Washington will be busy in the coming months. moving vaccine and rebuilding the economy. Although these are headliners, we cannot afford to set aside the Equal Rights Amendment. The final barrier remaining is the time limit on ratification.

Congress passed the ERA and sent it to the states in 1972. Although no deadline was included in the Amendment itself, a procedural requirement added a ratification deadline of 1979. As the deadline approached and 35 of the required 38 states ratified, the deadline was moved to 1982. (Continued on pg. 6)

EQUAL RIGHTS AMENDMENT UPDATE

(Cont'd from pg.3) When no additional states ratified by 1982, many considered the ERA a dead issue.

Enter the Madison Amendment, submitted by Congress to the states in 1789, and ratified in 1992, more than 202 years after it was submitted for ratification. (Fun fact: Missouri became the 37th state to ratify the Madison Amendment on May 5, 1992.) The Madison Amendment precedent makes the ERA time limit seem arbitrary. If the Madison Amendment can be ratified after 202 years, why not the ERA after 49?

Amendment deadlines are 'owned' by the US House and Senate. They vote on the rules, they voted to extend the ERA deadline from 1979 to 1982, and they have the power to eliminate the deadline.

Spurred by the jolt of the Madison Amendment, three more states (Nevada, Illinois, and Virginia) have ratified the ERA in the past few years, bringing the total to 38 states.

If you want to seal the deal on full civil rights for women, if you want to prevent new legislation limiting or prioritizing the rights of men and women, act now. But what can we do, in the face of pressing business in the Capitol?

Draft your letters. When the bill is introduced to eliminate the ERA deadline, be ready to send your heartfelt words to our representatives.

A new year, especially this new year, requires new energy. May your positive energy rise and meld with the enthusiasm of ERA supporters everywhere.
