## TOO MANY ROADS, TOO LITTLE FUNDING

On February 17 at our "Lunch & Learn" event, we were pleased to hear a presentation by Travis Koestner, Assistant District Engineer from the Missouri Department of Transportation, about the funding situation for our roads and bridges.

About 25 people attended, including quite a few members of the general public who had heard about the event on KFRU Radio and KOMU-TV. We all know that there is a problem with adequate funding, especially since recent ballot issues have failed and the State Legislature hasn't acted on the problem. There has been a lot of discussion about possible funding mechanisms, but there seems to be very little agreement on how to resolve the problem. It is



important that we have good information when discussing the issue.

Mr. Koestner provided a handout entitled "Missouri's 325 System Fact Sheet" which included important background information on the challenges we face. Some facts to keep in mind:

- In 2017, MoDot's construction funding will drop to \$325 million.
- It will take all of the \$325 million in construction funding to keep primary roads and bridges in their current condition.
- Fuel tax revenues have become a diminishing revenue stream as cars have become more fuel efficient.
- The fuel tax rate has not increased for almost 20 years, while the costs of construction and repair of the roads have increased. What was 17 cents (state fuel tax per gallon) of purchasing power back in 1992 is now only 8 cents.
- The costs of asphalt, concrete and steel are as much as 200 percent more than they were in 1992.
- In 2017, Missouri will not have enough money to match federal funds. Federal funds provide a \$4 to \$1 investment that Missouri will lose if we don't provide the matching funds.

Mr. Koestner spoke for an hour, answering many questions from the audience. It was interesting that even among the attendees, it was apparent that there are differences of opinion on how to address the problem -- (for example, whether to have toll roads or not.)

As a state employee, Mr. Koestner could not give his personal opinion on how to resolve the problem, but he said (and the League, of course, agrees) that it is important that citizens have good information about it.

### **MONEY IN POLITICS CONSENSUS STUDY**

Are our politicians being bought by a few billionaires? After the Supreme Court's "Citizen's United" decision, massive amounts of "dark money" began flowing into political action committees. In Missouri we see the influence of one billionaire and nationally we read that the Koch Brothers are going to spend nearly \$900 million and very wealthy individuals of all political persuasions are contributing millions of dollars to influence the electorate.

The LWVUS is conducting a national consensus study about Money in Politics, which is clearly a very timely topic. This fall, local Leagues across the country will study the issue. As we receive study materials, we will provide the links to information for our members. In the fall we will plan a forum, a CAT TV program and a Lunch and Learn event on this topic to educate our members and the public. Then a consensus meeting will take place prior to the February 1, 2016 deadline.

In addition to the Money in Politics study, the local Leagues will also be looking at what it involves to

change the U.S. Constitution. We will also provide materials and information on this study. Both studies were approved at the June 2014 LWVUS National Convention.
