MARCH 7 FORUM FOR APRIL ELECTION — UPDATE

The LWV and the Columbia Public Library will cohost a Candidate and Ballot Issues forum on Tuesday, March 7, at 6:30 p.m. in the Friends Room. The forum will feature the candidates for Columbia School Board and City Council Ward 5 and the ballot issues on the April 4th ballot. (Nick Knoth is now the only candidate for Ward 1, and our forums only include races with two or more candidates.) This forum will have both an in-person and a Zoom audience.

Columbia School Board candidates are Paul Harper, John Potter, Chris Horn, James Gordon, John Lyman, April Ferrao, and Chuck Basye. The library's hybrid setup cannot accommodate seven candidates at one table, so we will interview the candidates one at a time. To avoid putting the first candidate to be interviewed at a disadvantage, we will provide the questions to all the candidates ahead of the forum. Candidates will have a two-minute opening statement and a one-minute closing statement. High school students have prepared a unique question for each candidate.

Candidates for Ward 5 are Donald Waterman and Gregg Bush. With fewer candidates to interview, we can use our normal forum setup with candidates seated side-by-side. Candidates will answer moderator and audience questions and have a two-minute opening statement and a one-minute closing statement.

On the April ballot, voters will decide city and county ballot issues related to marijuana sales taxes. Kip Kendrick, Boone County presiding commissioner, will speak on the county issue, and Sydney Olsen, Public Information Officer for Columbia, will speak on the city ballot issue.

David Lile will be our moderator and KFRU and KOPN will broadcast the forum live. To attend the forum on Zoom, go to <u>dbrl.org</u> to sign up.

We are creating a Voters' Guide to help voters learn about items on the April 4th ballot. We hope to have the Voters' Guide available by March 15. A link will be sent to our members and posted on our LWVCBC website.

PRESIDENT'S MESSAGE

February has been a very busy month!

LWVCBC Board Members plus a few regular members met twice in February for several hours to discuss, review and recommend LWVMO Positions and Priorities for the coming two years in preparation for the May 6 LWV State Convention, to be held here in Columbia.

We are recommending that the LWVMO adopt the two local League positions we approved last year, after extensive studies, on 1) Local Control and 2) Marijuana Legalization.

We also listed our recommended priority issues for our local and state public policy action in the coming year:

- Protecting and enhancing voting rights/ Stopping Voting Restrictions
- Local control (State adoption of our LWVCBC position & study- approved in 2022)
- Climate protection and related environmental issues
- · Gun safety and control
- Reproductive rights
- · Preserve & Protect the Sunshine laws
- LBGTQ discrimination/equality/rights

Also in February, Marilyn McLeod, LWVCBC Board Member and LWVMO President, courageously and persistently testified many times in Jefferson City against numerous proposed bills that threaten the initiative petition process and our voting rights. Thankfully she was also able to testify in support of a few bills.

Other League Board Members and regular members submitted written testimony and/or contacted their Representatives and various committee members about proposed legislation. Thanks to all of you! We need you to keep weighing in on proposed state legislation in the coming months. We will do our best to keep you updated and informed and send out ACTION emails to you.

Kudos and thanks also go this month to:

- Carol Schreiber for her diligent work on the Voters Guide and for organizing the election forums for the April 4th election.
- Linda Smith and Linda Headrick for working on voter registration and to all those who have volunteered to register voters.
- Our Education Committee for doing excellent outreach to our High Schoolers, getting them registered and prepared for responsible voting. (Cont'd on pg. 6)

Celebrate Sunshine – Open Government is Good Government

Please mark your calendars for a March 13 educational presentation about the Missouri Sunshine Law and how it is used. The Observer Corps committee of the Kansas City League is hosting the virtual event at 6:30 p.m. on March 13, 2023. Our knowledgeable panel comprises Moderator Dave Helling, journalist emeritus; Steve Vockrodt, investigative editor, NPR Midwest Newsroom; and Max Kautsch, Kautsch Law, LLC, a lawyer whose practice focuses on First Amendment rights and open government law. They will share their experiences with the Sunshine Law and answer questions.

This event, which is free and open to the public, recognizes Sunshine Week and the 50th Anniversary of the Missouri Open Meetings and Records Law. To register for this Zoom event, visit https://bit.ly/LWV-zoom-2. The event recording will be posted on lwvkc.org and the @LWVKC YouTube channel.

Why is the Missouri Sunshine Law important? It is designed to limit corruption and increase public trust by requiring transparency. The League of Women Voters believes that democratic government depends upon informed and active participation by citizens at all levels

of government. The League further believes that governmental bodies must protect citizens' right to know by giving adequate notice of proposed actions, holding open meetings, and making public records accessible. The League's Observer Corps program is built on its decades of experience in empowering citizens to monitor local governmental meetings and inform the public of issues of concern.

Join the event on March 13, 2023. Remember, government transparency improves our lives and makes our communities stronger. Come learn how the "Show Me State" does Sunshine and why protecting the law going forward is so important.

<u>Sunshine Week</u> is a national observation sponsored by the <u>News Leaders Association</u> as an initiative to promote open government.

IN MEMORIAM





We are sad to report that we lost two titans of our local League in the last few weeks.

Shirley Troth passed away on Tuesday, January 31, 2023. She was born on June 21, 1935, in Mt. Lebanon, Pennsylvania, attended Stephens College here in Columbia, and then went on to further her education at Ohio State and Johns Hopkins University. Shirley joined the League in 1961 and was one of our longest-serving members – more than 60 years! She added the rural perspective to our deliberations as she and her husband operated a farm in the county. Shirley was a stalwart member of our board of directors for decades, ending that service to the League in 2020. During her years on the board, she often chaired our Budget Committee, one of those unsung but critical positions that kept our financial picture sound.

Lael Von Holt passed away on February 20, 2023. She was born on April 9, 1927, in Massachusetts. Lael joined the League in 1974 and served as a member of the local LWV Board for more than thirty years. She was co-president

during the 75th League anniversary year and helped arrange the many events of that commemoration. Lael also served as a board member of the state LWV, sharing her expertise statewide.

Quiet and dignified, Lael was known for her leadership in the mental health field, both in her professional life and her countless hours spent in the quest to obtain good healthcare services for people with mental illness, using the platform of the League as the springboard. She encouraged League members to not only be informed but to get involved. Until her last days, she was still interested in what the League was doing; the latest LWVCBC *Voter* was on the table near her easy chair.

We will miss these two inspirational members of the League for their wisdom and generous contributions of their time and talent to our organization for decades.

Second, in partnership with Columbia Public Schools, LWVCBC members are registering new young voters and helping them create a plan for voting in the April 4 election. LWVCBC members are staffing tables during lunch breaks at local high schools in late February and early March. Until the registration deadline of March 8, the focus will be on registration.

From March 9 – April 4, the focus will be on getting out the vote (GOTV). The GOTV literature suggests that the following contribute to getting people to the polls:

- Help voters create a plan and feel prepared to vote
- · Make it fun!

CLIMATE AND ENERGY UPDATE

The LWVCBC will have a table at Earth Day in Columbia on Sunday, April 22. Contact Barbara Hoppe at yesforparks@hotmail.com if you want to help. Barbara will also speak at the MU Climate Day Rally on Saturday, April 21.

There is no better way to show love to others and mother earth than by addressing human-made Climate Change locally and globally. Most appropriately, Carolyn Amperan, the Local Sierra Club Chair, was the speaker for our Lunch & Learn on February 14. If you missed her, you MUST watch this Lunch & Learn Program and share it with others!! She outlined these necessary GOALS for Columbia:

 Columbia Water & Light (CWL) must achieve 100% clean, renewable energy by 2030 in order to achieve a 50% reduction in emissions by 2035. Our current renewable energy ordinance requires a 30% reduction by 2029. CWL and the Energy Authority are studying this, and a report is due in May or June of this year. The report will provide multiple case study approaches to 100% renewable energy for CWL by 2030 and how

- to provide sufficient capacity and energy to meet 24/7 demand and regulations.
- Adopt minimum efficiency standards for rental housing in Columbia,
- Adopt the 2021 International Building Codes for Energy Conservation
- Reduce emissions and energy demand for all city buildings.
