THE STATE OF THE RIGHT TO VOTE IN MISSOURI AND BEYOND



In the words of the Supreme Court, the right to vote is preservative of all other rights. The voting booth is the one place where all are presumed equal. But is this basic right safe? At this program in recognition of Constitution Day, special guest speaker Denise Lieberman will share what is happening at the state and national level that has an impact on this basic right.

The Advancement Project's Voter Protection Program works to identify and remove systemic barriers to voting. Denise Lieberman is a constitutional and civil rights lawyer who works on the ground in Missouri in addition to advancing broad voter protection initiatives nationwide. She has emerged as a nationwide expert on voter identification laws, has frequently testified before legislative bodies in Missouri and other states, and works closely with election officials and community groups to advance

administrative and legal reforms in election administration.

This program is co-sponsored by the League of Women Voters of Columbia-Boone County and the American Association of University Women-Columbia Chapter.

The program is free and open to the public.

Twelve board members were present at the August Board Meeting. The Board heard updates on September events: picnic plans; Lunch and Learn; Voter Rights forum update; and voter registration at Columbia College and MU.

The Board was updated on the LWVMO Fall Conference for November 15 in Sedalia. Details will be sent out soon by the state League. Our local League will provide free registration for at least six members to the Fall Conference.

A request was made by LWVMO to have a representative from each League to be part of the committee to plan the May 2nd and 3rd State Conference to be held at the Lake of the Ozarks. Joni O'Connor volunteered to be our representative.

The Board received a nomination for our Outstanding Citizen Award. Nominations are open until September 15. Please, send your nominations to lwvcbc@gmail.com.

Many League members contributed to the \$10,000 fund raiser required to pay for Virginia Minor's statue for the Hall of Famous Missourians and we have been invited to attend the dedication. Ava Fajen and Joni O' Connor

will represent our local League at the ceremony on September 10th.

The Board approved:

- A fall fund raising campaign called \$95 for 95 Years to celebrate our 95th Anniversary this December. Details will be announced in the October Voter.
- Co-sponsorship of the local Global Climate Change March scheduled for September 21 and approved \$25 to help pay for fliers.
- Ed Fund request for the January 22nd Energy Matters Forum on the Columbia energy rating system for homes.

SEPT. 10: CELEBRATE THE ADDITION OF VIRGINIA MINOR TO THE HALL OF FAMOUS MISSOURIANS





Virginia Minor, 1824-1894

Virginia Minor will be inducted into the Hall of Famous Missourians on Sept. 10, 2014. You are encouraged to attend the ceremony, to be held in the House Chamber, on the Third Floor of the State Capitol at 9:00 a.m. The unveiling of the bust, designed by Missouri sculptor Cynthia Hitschler, will be followed by a reception. This will be a busy day at the Capitol, as the Legislative Veto Session also begins.

Virginia Minor led the fight for women's suffrage in Missouri. She was a co-founder and the first president of the Woman's Suffrage Association of Missouri. In 1872, she led hundreds of women in an effort to get women the right to vote under the 14th Amendment. She attempted to register to vote in St. Louis, but was refused. With her husband as her lawyer, she filed suit in the Missouri state courts. The case, Minor v. Happersett, went all the way to the Supreme Court which agreed with the lower courts that women were not covered by the 14th Amendment's guarantee of equal citizenship for all

Americans. Not until 1971, nearly 100 years later, did the Court finally apply the 14th Amendment to women. Minor studied law and continued her work for women's suffrage until her death in 1894.

After Virginia Minor was successfully nominated, by public vote, to be added to the Hall of Famous Missourians at the Capitol, the funds to pay for the sculpture had to come from private sources. A successful campaign called 1000 Strong (\$10 X 1,000) has now raised the required \$10,000. Minor will be only the eighth woman to be honored in this way in Missouri.

Candidate/Ballot Issue Forums set for October 21 & 23

General Election races will be the focus of our October 21st forum. These races include State Representative Districts 44 and 47; Boone County Presiding Commissioner; Boone County Recorder; Boone County Collector; and Division 5 Associate Judge.

Ballot Issues will be presented at our October 23rd forum. We will have pro and con speakers on some of the controversial issues and provide pro/con information on all of the issues. State issues include Amendment 2-For Child sexual abuse trials the law makes past criminal acts admissible; Amendment 3-Teacher tenure; Amendment 6-Six day early voting; and Amendment 10-Prohibits the Governor from estimating state revenue for budget recommendations. And two Columbia issues: property tax increase and development fees. Both forums will be in the Friends Room at the Columbia Public Library at 6:30 p.m.

Refreshments will be available at 6:00 p.m. KFRU will broadcast the forums live and David Lile will moderate the October 21st forum and Renee Hulshof will moderate the October 23rd forum. The forums are co-sponsored by the Columbia Public Library.
