#### Who Own\$ the Election?

Many feel that the Citizens United Supreme Court decision unleashed the unprecedented amounts of money already spent during the 2012 election cycle; others argue that the influx has other causes.



On Tuesday, September 18, the Civil Liberties Committee will present "Who Own\$ the Election?" as part of its Constitution Day celebration. Two distinguished professors from the University of Missouri, Jeff Milyo, Middlebush Professor of Social Sciences and Senior Fellow at the CATO Institute, and Marvin Overby, Middlebush Chair in Political Science, will explore the effect of the landmark Supreme Court decision in Citizens United v Federal Election Commission on financing the 2012 campaigns.

Professor Milyo has served as an expert witness in several state and federal election-related disputes and provided expert testimony on election administration to two US Congressional committees.

Professor Overby's research interests are broad and include legislative procedures in the U.S. House and Senate, the politics of minority groups, and campaign advertising.

The event will take place in the County Commission Chambers of the Roger B. Wilson Boone County Government Center, 801 East Walnut. (Please note that because of ongoing construction you should access the Chambers from the Ash and 8th Street side.)

Light refreshment will be provided at 6:30; the program will begin at 7:00 p.m.

The LWV Board approved the request. The Columbia School Board will finalize plans for this election at their September meeting. The school district has requested us to have a League member at each school to oversee the election, so we need at least 32 volunteers to work a two-hour shift. # CAT TV Show Explores the Status of Higher Education in Columbia and What Can Be Done to Reduce Student Debt

A recent report by the College Board was released concerning trends in tuition and fees, enrollment and state appropriations. Some of the surprising results were that:

- For the past three years, Missouri's four-year institutions' tuition and fees increases were the lowest in the country;
- State appropriations for higher education in Missouri declined by 5% over the last five years and Missouri ranks 44th in state appropriations per \$1000 income;
- Student enrollment over the past five years grew 17.6 % for four-year degree institutions and 28.6 % for community colleges.

To discuss these findings and address the serious issue of student debt, the LWV is inviting representatives from Columbia's higher education campuses to our September 12th CAT TV Show, in the CAT-TV studio, Windsor Hall, Stephens College. The show airs at 7:00 p.m.

#### **Short Notes from Committee Board Reports**

Prior to each monthly board meeting, committee chairs share what their respective committees are working on. Here are selected notes from those reports. If something catches your attention, all committee meetings are open and always welcome new potential members!

Education Committee: "At our July meeting, Dr. Rebecca DeNeve, Senior Legislative Analyst for the Missouri House of Representatives spoke to us about Missouri education issues. She writes the language for the related House bills, based on the requests of the bills' sponsors, and explained this process for us. One aspect that was surprising to us was the confidentiality that is preserved for the legislator who is working on a potential bill. It can occur that Becky will be writing bills on the same topic for different legislators independently of each other and she will discuss each only with the sponsoring individual. She also keeps confidentiality regarding the content of potential House bills when interacting with her counterparts on the Senate Research Staff. It seems inefficient, but she explained that it is necessary.

Becky also talked about the volume of bills that are handled in a legislative session. In the 2012 legislative session 1069 House bills were filed. Of the combined House and Senate bills filed, 131 were in some way related to education. Of those 131, 90 were assigned to the House Education Committee (K-12), 29 were officially heard by the House Education Committee, and 4 were actually passed. Of the four bills related to education that originated in the House or Senate education committees, 3 came from the Senate and 1 from the House. A number of bills passed in this past session affected education but did not originate from the education committees.

One of the most important things that needed to be done in the past session was to make adjustments to the foundation funding formula for education, but this was not accomplished. Probably the most important education bill that did pass was the expansion of charter schools. This legislation allows charter schools to be established in any unaccredited school district, provisionally accredited district, or in accredited districts with local school board sponsorship. We also discussed the language of the proposed constitutional amendment no.2, which has since been voted in at the August primary election.

Becky provided us with some context by noting that many other states are seeing the same types of bills we see in Missouri – for example, the recurring push to try to divert funds away from public education in order to give tuition tax credits to those who attend private schools."

<u>Energy Matters</u>: "The Energy Matters committee has tentatively decided not to schedule regular monthly meetings next fall, but instead to put our energies into planning a public forum for November." <u>Mental Health</u>: "Mental health - or lack thereof - has certainly been highlighted of late by country-wide tragedies of violence, loss of life and child sexual abuse.

But a more positive statement can also be made on mental health bynoting the Patient Protection and Affordable Care Act, which is now constitutional law and which recognizes the essential nature of mental health in overall health. Benefits are quite evident such as no exclusion from pre-existing conditions, no life time limits, collaboration in community clinics between health and mental health services, coverage up to age 26, expansion of substance abuse treatment, and mental health parity in insurance. Time will tell if these benefits have a significant impact."



<u>Voter Service</u>: "The Voter Service Committee will be involved with the Columbia Teachers Collective Bargaining Vote, if approved by our board and the Columbia School Board. We will need about 35 volunteers to work the election.

We will work on VOTE411 next week and try to get all of our candidates in the system.

The Committee will also pursue voter registration events for Centro Latino and Services for Independent Living. We are also waiting to hear from AAUW about activities for the Get Out the Millennial Women Voters activities."

#### 1914 State Convention in Columbia

The historical records of the local chapter of the League of Women Voters are at the State Historical Society of Missouri located in the Ellis Library building (University of Missouri-Columbia). The records consist of official Minutes, newspaper articles, scrapbooks and other papers. These records are considered a permanent collection of the Historical Society and cannot be removed from that location but they can be viewed there and copies can be made. We express our appreciation for the availability of the collection and the very helpful assistance of their staff.

Each month, we will present a brief article in our LWVCBC Voter sharing information about our history based on the papers in the collection. Note that sometimes it is difficult to decipher the handwritten notes, so some unintended errors may occur.

The Executive Committee of the Columbia Equal Suffrage Association met on January 9, 1914 where it was decided that the group should hold monthly open meetings featuring speakers on topics related to their mission. In February, several members addressed the topic "Why I Believe in Equal Suffrage." In March, Mrs. Helen Guthrie Miller spoke on "Suffrage for Missouri in 1915", and Professor Grover Hosford spoke on "Where Women Have the Vote and What They are Doing With It." In March, Professor Max Handmann spoke on "Snobbishness and Feminism"!

A few months later, a front page story in the *Columbia Tribune* (May 19, 1914) reported on the annual convention of the **Missouri Equal Suffrage Association** which was held in Columbia. Mrs. Miller was elected president of the state organization.

Another article in the same issue of the newspaper focused on the "Suffragists at a Banquet" where Mrs. St. Clair Moss and Dorothy Dix, a New York newspaperwoman, were the featured speakers. About 175 people attended. Dorothy Dix ( see picture at right) was a nationally known columnist ("Dorothy Dix Talks" for 33 years until her death in 1951); her talk was mostly about journalism with just a few references to suffrage, although the presence of such a nationally famous and successful woman had to be enough of a message in itself

Mrs. St. Clair Moss was very inspiring, with quotes such as "There is no woman problem. There is no suffrage problem. It is a problem of humanity..... The danger to society today is not from the thinking, active, industrious woman who is ambitious to be entrusted with the ballot and to take a part in community life"

As president of Christian College and a woman, she also spoke about the importance of access for women to higher education.

"Fifty years ago the doors of higher education were thrown open to women and without other assistance women have emancipated themselves, one of the most striking achievements in history."

She then gave examples of some of the famous women in high positions in America and "this shows the woman can do the work the world wants done."

Rev. W. W. Elwang spoke on women's suffrage from a man's standpoint, pointing out that the convention itself was proof that women have the ability to take part in politics "with wisdom and force".

During the legislative session, the Missouri Equal Suffrage Association and other allied organizations had been unable to convince the legislature to pass a bill on suffrage for women. As a result, there was a plan to get a constitutional amendment on the November ballot. This was a major topic of the convention.

They raised \$1000 for the "furtherance of the campaign for equal suffrage in Missouri," with the largest single donation of \$100 by Mrs. W. H. Willis of Columbia. The group "instantly agreed" upon a motion to have more printed matter distributed to the various suffrage leagues around the state for use in the campaign to give out at fairs, picnics and all public gatherings during the summer.

#### **October Election Forums Take Shape**

LWV will be sponsoring two candidate/ballot issue forums for the November General Election. Both forums will be in the Friends Room at the Columbia Public Library with refreshments at 6:00 p.m. and the forums at 6:30 p.m. Thursday, October 4th we will have the contested Boone County State House and Senate races. The House races include: District 44 with Ken Jacob (D) and Caleb Rowden (R); District 46 with Stephen Webber (D) and Fred Berry (R); and District 47 with John Wright (D) and Mitch Richards (R). The 19th Senate candidates are Mary Still (D)

and Kurt Schaefer (R). We will conclude with an historical presentation on the St. Louis City Police Department (Municipal Police Department Control) ballot issue. The St. Louis City Police have been governed by the State of Missouri dating back to the civil war and this ballot issue would give control back to the city. This current ballot issue seems to have the support of both the St. Louis Police Department and the Mayor of St. Louis.

Tuesday, October 9th we will have the contested Boone County races and the rest of the ballot issues. For Boone County Public Administrator we will have Cathy Richards (D) and John Sullivan (R). For County Commissioners we have: Northern District (District II) candidates Janet Thompson (D) and Don Bormann (R); and for Southern District (District I) candidates Karen Miller (D) and James Pounds (R). Since, we have a Democratic Governor the ballot order will be Democratic candidate first with the Republican candidate second. We do not have the final list of ballot issues. We plan to have pro and con speakers where possible. If we are unable to find speakers, League members will present summaries of pros and cons for the ballot issue.

If at any point you decide you might like to change your mind it is easy to change or remove the beneficiary designation. If you have a large estate, and are considering possible tax deductions, please contact your tax advisor.
