JULY 14 FILM: "ONE WOMAN, ONE VOTE"



MAY BOARD MEETING REPORT

The LWV Board of Directors met on Monday, May 20, 2019, holding a brief regular board meeting followed by an orientation and planning meeting.

New Board

We welcomed new board members Kate Canterbury and Susan Clark. President Marilyn McLeod went through the LWV Handbook and explained various policies and where to get needed forms and information. The Board decided to keep the third Monday as the regular Board meeting date and to continue meeting at the Unitarian Universalist Church.

Each Board member shared their work experiences, interests and skills that will help the Board and the League.

New Committees

Members reviewed the list of our committees and noted that we have a new committee, the ERA Committee. Carol Schreiber reported that LWVUS is encouraging local Leagues to work on the census and they have a toolkit on their website. Carol will be the interim chair for the census committee and anyone interested in serving on this committee should email Carol.

Communication Tools

We are using a number of communication tools to share our activities with members and the general public. Ava Fajen will continue preparing the Voter. Marilyn McLeod will continue sending out press releases and will manage the website, lwvcbc.org. Peggy Placier will manage our Facebook page. Kate Canterbury has suggestions on making our Facebook presence stronger and will help us become more active on Twitter. We plan to continue to share our activities on the radio program "Radio Friends with Paul Pepper." Since we will no longer be able to provide programs via CAT TV, it was suggested that we investigate additional radio opportunities and possibly film or prepare podcasts of our other educational programs, such as Lunch & Learn, to be shared on YouTube.

Membership Drive

Membership chair Meredith Donaldson will begin the drive for membership renewals in August and we will provide orientation activities for new members and encourage them to attend the August event and another one in January or February.

\$100 for 100 years!

This is our centennial year, and the board approved a special fundraising request for this centennial year. We will encourage members to give an extra donation when renewing their membership. For individuals we will ask they give \$35 extra to make it \$100 and for couples to give \$125 instead of \$100.

Lunch & Learns Cosponsored with Library

We have been providing monthly Lunch & Learn programs for several years, moving them to whatever location is available. We now have an opportunity to cosponsor these programs with the Columbia Public Library, which will provide a centralized, permanent location with other positive benefits. These programs have an educational mission which works well with the library's mission.

The Board will consider some other evening activities (in addition to regular forums) to engage members who work during the day.

Centennial Celebrations

Plans are in the works for a variety of events, as part of our centennial celebration (see the report of the 100th Anniversaries Committee on page 4). Mark your calendar! We will have a showing of the film about the suffrage movement "One Woman One Vote" on Sunday, July 14 at 2 p.m. at the library. We are working on a program for Constitution Day on September 18 and an event in October about the suffrage movement and the racial divide. We have been invited to participate in a symposium in October at William Woods University on October 21.

2019 LEGISLATIVE SESSION OUTCOMES

The 2019 Missouri legislative session ended on Friday, May 17. Here is a summary of some outcomes on issues important to the LWV, in alphabetical order. Please note the current and future outcome for Amendment I.

ABORTION. A restrictive bill prohibiting abortions at 8 weeks of pregnancy except in medical emergencies passed.

AMENDMENT I - REDISTRICTING AND ETHICS RESOLUTION. Although HCS/HJRs 48, 46 & 47 would have undone the redistricting reforms of Amendment 1, it did not pass due to a procedural error in the Senate committee on May 13. The majority party legislators may seek to force a similar provision through next session.

HJR 48 would have significantly undermined the redistributing reforms approved by voters in Constitutional Amendment 1, also known as CLEAN Missouri. It would have eliminated the nonpartisan state demographer and would have moved partisan fairness and competitiveness to the lowest priority in the redistricting process. The House also added language that could shift the basis of redistricting away from total population, as is currently the practice in all 50 states.

SB 213, regarding the nonpartisan state demographer, passed. It included protecting the process of redistricting against conflict of interest, providing for financial disclosure of the process, and increased public disclosure of records.

BUDGET. The legislature authorized a roughly \$30 billion operating budget for fiscal year 2020 (July 1, 2019-June 30, 2020). It included the full amount called for by state law to fund K-12 public schools, and a total of \$100 million of funds coming from general revenue for state bridge repairs and local highway projects. It continues a requirement to charge international tuition rates for college students living in the U.S. illegally.

CAFOs (Concentrated Animal Feeding Operations), LOCAL HEALTH ORDINANCES. Legislation was passed to prevent local officials from enacting regulations, such as county health ordinances, that are more stringent than state regulations for the CAFOs used to raise large numbers of livestock such as hogs, poultry or cattle.

CHARTER SCHOOL EXPANSION. Although committees in both the House and Senate quickly moved legislation allowing charter schools to be sponsored by outside entities (other than the local

school board) and operate in districts around the state, these bills did NOT pass—mostly because of many communications from constituents and the bipartisan opposition in rural areas.

CHILD CARE. Tighter limits on in-home child-care providers who currently are limited to caring for four children who aren't related to the caregiver passed. This creates a new limit of six children, including three under age two and exempts only school-age relatives.

HEALTH POLICY MEASURES. Proposals to enact Medicaid Work Requirements, to create Short-term Junk Insurance, and the Global Waiver/Block Grant did not pass and were not included in the Omnibus Healthcare Bill.

PRESCRIPTION DRUG MONITORING PROGRAM (PDMP). The prescription drug monitoring program did not pass for the 7th year. Missouri remains the only state that does not have a state-wide drug monitoring program. Many cities and counties have joined voluntary programs which now cover over 80% of the state's residents.

TAX CREDITS. Efforts to cut the Circuit Breaker tax credit for low-income seniors and people with disabilities did not pass. The Low Income Housing Tax Credit measures did not pass, although the Governor has stated that he will restart the program anyway. The most significant tax credit package approved was the General Motors Incentive, which also included a number of the Governor's priorities around workforce development.

TAX ISSUES. State revenue is up by about 2% compared to last year, although individual income tax collections remain lower than last year.

Proposals that would have made Missouri's tax structure even less fair and which would have harmed funding for critical community services were blocked. However, the "Wayfair Fix "and State Earned Income Tax Credit (EITC), two proposals the LWV supported, did not pass. The MCO provider tax, which would provide more funding to support Medicaid did not pass.

TERM LIMITS BALLOT ISSUE. There will be an issue on the next ballot to ask voters whether to limit Missouri's lieutenant governor, attorney general, secretary of state, and auditor to serving two, four-year terms in office (similar to current term limits for governor and state treasurer).

The Boone County Commission will be issuing a proclamation that December 7-14 be LWV week commemorating the 100th Anniversary of the founding of the

LWV of Columbia, and we will be asking Mayor Treece to do the same.

July 2019: Chris Crawford, Laurel Wilson and Nancy Taylor of the Boone County Museum and Culture Center and Marilyn McLeod and Pam Springsteel are assembling an exhibit honoring the 100th anniversary of the founding of our local league and the 100th anniversary of the XIX Amendment, entitled At Last Their Work Bore Fruit: Winning the Vote. They are requesting loan of artifacts from the early years of the league or women's voting to put in the display casespersonal items, awards, pins, sashes, paragola t shirts handbills atc. Contact

parasols, t-shirts, handbills, etc. Contact Pam Springsteel if you have any items to lend. Mark Farnen, who has a large collection of political pins, is gathering pins of politicians of the suffrage era to lend to the exhibit. Marilyn will be writing letters to the editor of area newspapers to make this same request.

August 26 - 99th Anniversary of the XIX Amendment: This celebration will be held at Parks and Rec's Rock Quarry House, 5:30-7:30 p.m. Carolyn Rempf, MU history professor, will speak on U.S. women's political history. We will award the Liz Schmidt Scholarship, provide orientation of new members, and enjoy sandwiches, veggie and fruit trays, and drinks. There will be musical entertainment - a sing-along with the Joy Boys. We will need some members to arrive early to set up tables and chairs and to take down after the event is over.

October 2019- Marilyn is contacting Dr. April Langley, Chair of Black Studies and Associate Professor of English about a possible event at the library in which we would invite women of color. April wrote an article in the current (Missouri) Humanities magazine about a black suffragist-Frances Ellen Watkins Harper. The article is entitled

"BONDED JUSTICE: Race, Class, Gender, and Suffrage."

November 24, 3-5 p.m., Columbia's Holiday Parade: Three of our members will be riding in costume in Todd Crawford's Model T Ford, the "Billy T." Todd is looking for a second antique car so more members may be in the parade. Other

members can walk in the parade carrying banners. The parade goes from Broadway and College, west on Broadway to 5th and Locust. We will be creating a local League centennial banner from the template supplied in the toolkit on the lwv.us website. These banners will be on the sides of the car(s) and carried by those walking.

December 7 - Centennial Celebration of the Founding of our local LWV: A Saturday afternoon reception at Broadway Christian Church, with special invitations going to the Mayor, City Council, Boone County Commission and Friends of the League. The public will also be invited.

Commissioner Janet Thompson is preparing a proclamation from the Boone County Commission. The Mayor will be asked to proclaim this as LWV week. Mothersingers will entertain us with suffrage songs. There will be a speaker, presentation of the Liz Schmidt Community Service Award, and refreshments. We will be doing a special mailing of fancy invitations -1920's style.

December 11 - 100th Anniversary of the Founding of the League of Women Voters of Columbia -Janet Thompson, Brianna Lennon, and Kate Canterbury are planning this happy hour event at Dog Master Brewery with drinks and hors d'oeuvres. The owner has promised a signature cocktail. This will be a Facebook Event and invitations will be mailed out. We will be decorating with the "Our Turn" poster from the state league.

Contacts with Stephens College - We met with Diane Lynch, Stephens College president; Leslie Wiley, vice president of academic affairs; Lori Hall-Araujo, curator of the costume museum; and the public relations person. When the academic year begins, they would like to do joint events. We were shown fashions of the time.Brianna Lennon met with the director of the a cappella choir - the Velvet Tones. We will see if they are available to sing at our August 26, 2020 event. (cont'd on page 6).

(cont'd from page 4) Contacts with Columbia College - We have contacted Sam Fleury, assistant director of public relations, who agreed to help in our endeavor to get the next middle school named for Luella St. Clair Moss. Luella was the first female president of Christian College (now Columbia College), first female on the Columbia School Board, first president of LWVMO from Boone County, and first woman to run for US Congress (in 1924). A letter has been sent to members of the school board and the superintendent giving the reasons the middle school should be named for Luella. Jonathan Sessions responded that the public would be notified when they were ready to make a decision and an ex-officio committee of members of the school board would be formed to study the

Ragtag Theater - Vicky Riback Wilson is working with Ragtag to put together a series of films about

the suffragists, and to work with the Locust Street Expressive Arts School on an appropriate project. The films may include "Iron-Jawed Angels," "RBG," and "Knock Down the House."

Columbia Public Library- Marilyn and Pam met with Lauren Williams. Lauren got permission to have the library reprint 500 copies of the little poster which states "a woman who is registered to vote lives here." In July we will be showing the PBS Documentary "One Woman, one Vote" at the library.

MU Chancellor- Ann Deaton has offered to contact Chancellor Alexander Cartwright for us when we have a plan for what we want her to ask him. Ann also suggested we have an EqualiTea with AAUW and the chancellor's wife, Melinda Cartwright.

MAY 21 LUNCH & LEARN: INTERIM POLICE CHIEF GEOFF JONES

There was a good turnout for the Lunch and Learn Program on May 21. Interim Police Chief Geoff Jones was very informative, forthright and spent the majority of the hour answering questions from the interested and engaged audience.

He has lived in Columbia since he was 3 months old and has been employed in the Columbia Police Department since 1998. He has been a patrol officer, a Narcotics Detective, a Sergeant, Police Lieutenant, and most recently led the Community Policing program. Jones explained what he has done to

improve communication and morale within the Police Dept. and to improve Police/Public interaction. He answered questions about Police Stop disparities and the diverse committee that is working on this. He told us about the mental health training officers receive to help them deal with individuals with mental disabilities. He answered questions about Vision Zero, which helps reduce vehicle/ pedestrian accidents. There are 173 officers presently and he has recently reduced the number of

vacancies from 12 to 5. He would like to improve diversity when recruiting new officers.

Jones also told us what he carried on his belt. Asked about high speed chases, he explained how the old policy of allowing chases up to 20/25 miles in excess of the posted speed, to a more thoughtful approach that considered many factors. He explained why a traffic unit is needed as well as regular patrol officers. Patrol officers give attention to traffic violations only if they are not on or needed in a more urgent matter, while Traffic Officers can focus on traffic issues and

> give them high priority. Lastly, in response to a question about whether there was sufficient funding for the Police Dept., Interim Police Chief Jones said he felt that the Police Dept. should use the resources it has more efficiently, before considering more funding. Thanks again to Interim Police Chief Geoff Jones for a very informative and interactive Lunch and Learn session.

NOTE: There will be no summer **Lunch and Learn Programs. They** will resume in Sept.
