In normal years, we are always actively involved in registering voters; that is the one activity which we regrettably reduced this year because of the in-person requirement of that activity. Looking for creative ways to encourage voter registration, we decided to do that activity "virtually" with a daily post for 100 days (!) on our Facebook and Twitter social media sites - encouraging voter registration and providing voter information. We must give a major note of thanks to members Sharon Schneeberger, Peggy Placier, and Carol Schreiber for their amazing efforts in making that work.

And, despite this year's unusual situation, thanks to the efforts of our membership chair, Meredith Donaldson, we increased our membership to just over 200 members, which might be a record for our LWV chapter!
