

WHAT YOU NEED TO KNOW ABOUT MISSOURI'S NEW VOTING LAW

For the August Primary — Nothing is changed!

Current Missouri Election Laws are still in effect for the August 2nd Primary. That means you can use any of the traditional forms of ID to vote, including a MO driver's license or state ID, the voter registration card received from the Boone County Clerk, student IDs, bank statements, utility bills, etc.

New Election Law Takes Effect After August 28, 2022

A major election law bill - HB 1878 — was passed on May 13, the last day of the legislative session. It went from an eight-page bill to over 50 pages, was not clearly written, and most legislators did not know what was in it. Gov. Parson signed the bill on June 29 and the law will go into effect August 28, 2022. It will affect **future elections**, beginning with the November General Election.

The League is working with the MO Voter Protection Coalition and the Elections Division of the Secretary of State (SOS) office to understand the provisions of the new law and how the provisions will be applied.

Here are some of the major changes to the election laws and what possible action may be taken:

- Strict Voter Photo ID: The only ID allowed will be an unexpired Missouri driver's license or non-driver's license, an unexpired US passport, or an unexpired federal ID. The MO Voter Protection Coalition, along with others, plans to file a lawsuit to challenge this provision. We do not know what the Court will do.
- Voter Registration Volunteers must register with the SOS: LWV volunteers who register to vote ten or more people in the

two-year general election timeframe must register with the Secretary of State. Although there is a form now on the SOS website, the League has asked for clarification on whether there will be a revised form. The League believes this provision of the law will probably stand.

 It is prohibited to provide an absentee ballot APPLICATION to a voter without it being first requested by the voter. There are severe criminal liabilities in this provision. We expect this provision will be challenged in Court.

Two good provisions come with a very big caveat:

- Change of Address can be made at your polling location on election day.
- Allows TWO WEEKS of NO-EXCUSE absentee voting at the election authority's office but only during their office hours, and the strict photo ID will still be required. According to the law, if the strict photo ID part of the law is struck down by the Courts, then this provision will be struck down also.

There are many more provisions in this bill, and the League will keep you updated. The provisions of this law go into effect on August 28 and will be in effect for the November 8th Election. However, please note that it is possible that there may be a temporary injunction (or other action) by the Court on some aspects of the law. We will provide information if that happens.

HELPING YOUNG VOTERS FIND THEIR VOICES IN THE DEMOCRATIC PROCESS

The Education Committee has been working over the past 11 months to identify ways to increase/improve the education of young people, grades 9-12, to enable/encourage/expand their participation in the election process, including:

- · Registering to vote.
- · Voting.
- · Helping others to vote.

Through a partnership established with the leadership of Columbia Public Schools (CPS) and with input from CPS high school students, the Committee has identified the following strategies to advance this goal:

- Continue collaborating with CPS to create a presence in the high schools to eliminate gaps between learning and action.
- Focus LWVCBC education efforts with high school students on action. For example, making it easy for high school students to register to vote when they turn 18, and distributing sample ballots just before an election.
- Help to provide a forum for student voices to be heard.
- Take advantage of students' interest in contributing to these efforts, especially with

communications such as websites, posters, and group meetings. Young people's perspectives on effective outreach are critical. Experience is learning.

- Use electronics! Redesign the LWVCBC website for ease of use and have a section that focuses on young voters. Develop electronic methods to maintain dynamic contact with students who wish to affiliate with the League.
- Explore a youth membership option.

Next Steps In partnership with CPS leadership, other LWVCBC committees, and students themselves, Education Committee members will initiate work to:

- Create a youth section on the LWVCBC website.
- Implement Register-to-Vote birthday parties for CPS students when they turn 18.
- Develop get-out-the-vote-informed strategies to get students to the polls, including individualized voting plans.
- Develop and offer neutral nonpartisan issue forums.

COLUMBIA UTILITY RENEWABLE ENERGY UPDATE

The City Council on July 18 instructed Columbia Water and Light (CWL) to create a plan to achieve 100% renewable energy by 2030.

The first item on the agenda that evening was the 2022 Renewable Energy Plan, previously called the annual Renewable Energy Report. I and three others took the opportunity to again advocate for rapid action regarding renewable energy. The Climate and Environment Commission in March sent the Council a recommendation for 100% renewable energy by 2030. The Water and Light Advisory Board, which normally would be a major voice, has not made any comments on the timetable. Often in the past, the Council has simply "accepted" the report. This time there was considerable discussion regarding reaching 100% renewables. At the end of the Council meeting. when new items can be discussed, member Betsy Peters suggested that CWL provide a report on reaching 100% renewables by 2030. I think that report might reach the Council in two or three months, and at the second of two meetings the Council could vote upon it.

I take this opportunity to remind you that 100% renewable means that the utility will purchase a

quantity of renewable energy that equals the annual energy sold. There will still be some electricity used in Columbia that originates from fossil fuel, but this will be offset by renewable energy generated within the region. I also remind you that Columbia has no ability to cause the closure of coal-fired electric generators with which we have contracts and to whom we will still be paying the fixed costs within the contracts. (Those fixed costs are recognized by the Midcontinent Independent System Operator (MISO) — a regional transmission organization in which CWL is a member — as representing part of Columbia's required generation capacity for peak energy use.)

This is the time to tell the City Council that you support the League's position for 100% Renewable Energy by 2030. I expect the League to let us know when the Council will vote on the issue. The Council members are influenced by a strong show of public support, so it will be very helpful to have a large crowd of supporters at that meeting.
