OCTOBER 20 FORUM: DO GENETICALLY MODIFIED ORGANISMS (GMOs) AFFECT HUMAN HEALTH AND THE ENVIRONMENT?

Our forum on GMOs will be on Oct. 20, from 6:30 to 8:30 p.m. (please note early start time) in the Columbia Public Library Friends Room.

GMOs are an ever-growing part of our food supply, and many people have questions about their safety and environmental impacts. This forum will share some basic background information about GMOs—how they're developed and produced, and which crops are most likely to be GMOs. Several experts will then share different perspectives about the potential health effects of GMOs and the environmental impacts of GMO farming. Please come and participate in a lively conversation about an important topic.

Fourteen board members were present for the September 28th board meeting.

Board actions:

- Approved a \$200 donation to the Turning Point Suffragist Memorial (see Aug. Voter) in the name of former local and state board member Maydell Senn. LWVMO is trying to put together \$1000 in donations from Missouri so that we will be recognized on the Honor Wall.
- The December Social will be at the Unitarian Church the second week of December (we will try to get on the main floor for better access), and we will again bring socks for the homeless. Heavy white socks are the preferred socks. Members will bring snacks and drinks, and the social will be from 5 to 7 p.m. The exact date will be in the next Voter.

These special playing cards could be sold throughout the state and at the LWVUS National Convention. We will begin working on this project possibly with college art students. The needed quantity to get the best price is 2000 decks of cards.
- Each year our local League pays the registration of 6 members for the LWVMO Fall Conference. The 2015 Conference will be on November 7th in Sedalia. AMENDING THE CONSTITUTION: STUDY CONSENSUS MEETING OCTOBER 28

On Wednesday October 28 at 6:30 p.m. in Conference Room A at the Columbia Public Library, LWVCBC will hold our consensus meeting for the study on Amending the Constitution. Marilyn McLeod and David Leuthold will facilitate the process. To prepare for the meeting, you can:

- Review the discussion guide and questions included in the September Voter (if you can't locate yours, it's always available on the lwvbc.org website under Newsletters).
- Watch the video and read some of the sources cited in the discussion guide,

- especially the two very brief pro-con synopses.
- Watch the video of the Constitution Day presentation on Amending the Constitution by Dr. Justin Dyer on Mediacom.

Marilyn and David will skillfully guide us through the questions so that we can return our decisions (consensus or lack of it) to LWVUS.

If you have never participated in one of these meetings, please feel welcome to come. You don't have to be an expert on the Constitution, just an informed and thoughtful LWV member.

AMENDING THE CONSTITUTION: NOTES ON DR. DYER'S TALK

Our Sept. 16 speaker, Dr. Justin Dyer, a constitutional scholar from the MU Political Science Dept, said that the questions we are considering for our study on Amending the Constitution are difficult. Because some people were unable to attend and don't have MediaCom, a summary of his major points is provided below.

Basic Understandings of the U.S. Constitution:

- Not simply a piece of paper but a living document. Practice reveals the meanings of the Constitution in any period.
- Brief (especially compared with some state constitutions) and does a limited number of things. It does not specify practice. That is up to political actors in each period of time.
- The recourse for problems, in most cases, is to change practice rather than amending the Constitution.

Amending the Constitution:

- Article V of the Constitution sets out two processes (see our Discussion Guide in the September Voter).
- Founders intentionally made amending difficult, with super majorities required at all levels.
- Therefore, amending is not the best (and certainly not the fastest) route for policymaking.

- All amendments to this point have been adopted through the first process – Congress adopts (2/3 of each house) and sends to the states, three-fourths of which must approve.
- The second process, a Constitutional Convention, has not been tried and is full of uncertainty. The states have forwarded many petitions for a Convention to Congress, but they have not been sufficient. (It should be noted that groups are currently organizing convention petitions for a variety of reasons. You may see news about these.)

Citizens United:

- Because this Supreme Court decision inspired LWVUS to propose the study we are completing, I asked him about it.
- Dyer summarized the majority arguments in the case, which do have merits and had support from a spectrum of political groups. This was very interesting, as his response differs from what LWVUS has sent us (mostly against Citizens United).

The Bottom Line:

- Most changes in government occur outside of the Constitution, not through amendments.
- Dyer argued that we should not amend often, but should ask, "What other political process will achieve our ends?"

A THANK YOU NOTE


Lael Von Holt has shared a thank you card sent in response to the funding the LWV-CBC provided for Mental Health First Aid training for local teachers.

APPLY NOW FOR CITY BOARDS & COMMISSIONS!!!

A very important way to get involved in City Government, beyond voting every three years for your Council Member, is to serve on a City Board or Commission. The City of Columbia is accepting applications until 5 p.m. Friday, Oct. 9,2015 for numerous Commissions listed below. Applications are at the City Clerk's office or online at www.gocolumbiamo.com. (Click on "Meetings," then click on "Boards & Commissions" which will appear in a box on the left.)

Please consider applying or encourage someone you know to apply. When I was on Council I often would often call to recruit specific people to apply, to make sure we had good applicants. Note: Some openings may have specific qualifications, such as living in a particular ward, being from the County or having certain training or skills.

Important Things to Know:

- If you apply and don't get on the Board, ask the City Clerk to keep your application on file. (If someone on the committee is reapplying they may be the preferred candidate. However, eventually a spot will open and an existing members won't reapply. This is often the best chance to get appointed.)
- It is also helpful to send an email to at least four council members or more, sometime during the week prior to the next Council Meeting, when they will vote, Oct,19, 2015 in this case. Email a short paragraph: introduce

yourself, tell them why you want to serve on that commission, let them know you are a LWV member and highlight key training, service or skills you have that are relevant to the Commission.

Bertrice served on the LWV's Energy Matters Committee in the late '90's and helped pass Columbia's 2004 renewable energy ordinance. She was a board member and chaired our "Defense of Civil Liberties Task Force," which, in 2005, applied for and got a National LWV/MacArthur Foundation Grant. We were one of only ten Leagues funded to conduct a community conversation on the balance between civil liberties and security.
